I. Summary:

This legislation re-creates the Retiree Health Insurance Subsidy Trust Fund without modification, effective upon becoming a law. The Retiree Health Insurance Subsidy Trust Fund, FLAIR #72-2-583, is administered by the Department of the Management Services. This fund was last reviewed by the Legislature in Chapter 97-140.

II. Present Situation:

The re-creation of the Retiree Health Insurance Subsidy Trust Fund would provide funding for retiree health insurance subsidies to be administered within the Department of Management Services.

This bill re-creates the trust fund without modification.
