Subsection (2) of section 90.404, Florida 25 26 Statutes, is amended to read: 90.404 Character evidence; when admissible.--27 28 (2) OTHER CRIMES, WRONGS, OR ACTS.--29 Similar fact Evidence of other crimes, wrongs, or 30 acts is admissible when relevant to prove a material fact in

opportunity, intent, preparation, plan, knowledge, identity, or absence of mistake or accident, but it is inadmissible when the evidence is relevant solely to prove bad character or propensity.

- (b)1. In a criminal case in which the defendant is charged with a crime involving child molestation, evidence of the defendant's commission of other acts of child molestation is admissible, and may be considered for its bearing on any matter to which it is relevant.
- 2. For the purposes of this paragraph, the term "child molestation" means conduct proscribed by s. 794.011 or s. 800.04 when committed against a person 16 years of age or younger.
- (c)(b)1. When the state in a criminal action intends to offer evidence of other criminal offenses under paragraph (a) or paragraph (b), no fewer than 10 days before trial, the state shall furnish to the <u>defendant or to the defendant's counsel accused</u> a written statement of the acts or offenses it intends to offer, describing them with the particularity required of an indictment or information. No notice is required for evidence of offenses used for impeachment or on rebuttal.
- 2. When the evidence is admitted, the court shall, if requested, charge the jury on the limited purpose for which the evidence is received and is to be considered. After the close of the evidence, the jury shall be instructed on the limited purpose for which the evidence was received and that the defendant cannot be convicted for a charge not included in the indictment or information.
  - Section 2. This act shall take effect July 1, 2001.
