B. PRESENT SITUATION:

The Civil Service System for certain employees of the City of Pensacola was originally created by Chapter 63-1776, Laws of Florida, effective June 14, 1963. The City of Pensacola is required to petition the Legislature for a special act each time the City seeks to amend its Civil Service System Act.

C. EFFECT OF PROPOSED CHANGES:

This bill places the City of Pensacola's Civil Service System under local control by converting the various special acts relating to the Civil Service System of the City of Pensacola into a municipal ordinance.

D. SECTION-BY-SECTION ANALYSIS:

Section 1: Converts Chapter 84-510, Laws of Florida, as amended by Chapters 88-537, 86-447, and 90-473, Laws of Florida, into an ordinance of the City of Pensacola.

Section 2: Provides an effective date of upon becoming a law.
