I. SUMMARY:

This bill amends the charter of the City of Jacksonville to clarify existing civil service exemptions and to exempt additional positions from the civil service system of the Duval County/City of Jacksonville consolidated government. This bill also removes a limitation providing the consolidated government may not employ part-time and temporary workers for longer than 6 months without extension by the chief of personnel.

No fiscal impacts are anticipated according to the Economic Impact Statement (EIS).

B. PRESENT SITUATION:

The civil service provisions of the charter of the City of Jacksonville consolidated government apply to all employees of the consolidated government that are not specifically exempted. The City of Jacksonville is required to petition the Legislature for a special act each time the City seeks to amend its charter.

C. EFFECT OF PROPOSED CHANGES:

This bill amends the subsections (d), (f), (g), (y), and (z) of section 17.06 of the charter of the City of Jacksonville, as created by chapter 92-341, Laws of Florida, as amended. This bill clarifies existing civil service exemptions and exempts additional positions from the civil service system of the Duval County/City of Jacksonville consolidated government. This bill also removes a limitation providing the consolidated government may not employ part-time and temporary workers for longer than 6 months without extension by the chief of personnel.

D. SECTION-BY-SECTION ANALYSIS:

**Section 1:** Amends section 17.06 of chapter 92-341, Laws of Florida, the charter of the City of Jacksonville; provides and clarifies that the chief of staff, regional superintendents, associate and assistant superintendents, chief information officer, administrative assistants to the superintendent, directors, supervisors and coordinators, specialists in administrative or educational services, and secretary to superintendent are exempt from the provisions of the civil service system; removes a limitation providing the consolidated government may not employ part-time and temporary workers for longer than 6 months without extension by the chief of personnel; replaces the civil service exemption for the executive director of the community relations commission with a civil service exemption for the executive director of the commission on Human Rights and the director of equal opportunity/equal access; clarifies that civil service exemptions apply to all executive assistants of library services.

**Section 2:** Provides and effective date of upon becoming a law.
