16	Be It Enacted by the Legislature of the State of Florida:

18	Section 1. Section 455.2281, Florida Statutes, is
19	amended to read:
20	455.2281 Unlicensed activities; fees; dispositionIn
21	order to protect the public and to ensure a consumer-oriented
22	department, it is the intent of the Legislature that vigorous
23	enforcement of regulation for all professional activities is a
24	state priority. All enforcement costs should be covered by
25	professions regulated by the department. Therefore, the
26	department shall impose, upon initial licensure and each
27	renewal thereof, a special fee of \$5 per licensee. Such fee
28	shall be in addition to all other fees collected from each
29	licensee and shall fund efforts to combat unlicensed activity.
30	Any profession regulated by the department which offers
31	services that are not subject to regulation when provided by

1 an unlicensed person may use funds in its unlicensed activity account to inform the public of such situation. The board with 2 3 concurrence of the department, or the department when there is no board, may earmark \$5 of the current licensure fee for this 4 5 purpose, if such board, or profession regulated by the б department, is not in a deficit and has a reasonable cash 7 balance. A board or profession regulated by the department may 8 authorize the transfer of funds from the operating fund 9 account to the unlicensed activity account of that profession 10 if the operating fund account is not in a deficit and has a 11 reasonable cash balance. The department shall make direct charges to this fund by profession and shall not allocate 12 indirect overhead. The department shall seek board advice 13 regarding enforcement methods and strategies prior to 14 expenditure of funds; however, the department may, without 15 board advice, allocate funds to cover the costs of continuing 16 17 education compliance monitoring under s. 455.2177. The 18 department shall directly credit, by profession, revenues 19 received from the department's efforts to enforce licensure 20 provisions, including revenues received from fines collected under s. 455.2177. The department shall include all financial 21 and statistical data resulting from unlicensed activity 22 enforcement and from continuing education compliance 23 24 monitoring as separate categories in the quarterly management report provided for in s. 455.219. The department shall not 25 charge the account of any profession for the costs incurred on 26 behalf of any other profession. For an unlicensed activity 27 28 account, a balance which remains at the end of a renewal cycle 29 may, with concurrence of the applicable board and the 30 department, be transferred to the operating fund account of that profession. 31
