I. <u>SUMMARY</u>:

This bill creates the Rural Lands Program Trust Fund to receive Rural Lands Protection Bonds proceeds and to pay debt service on those bonds. The trust fund will be administered by the Department of Agriculture and Consumer Services.

This bill does have a fiscal impact.

The bill provides this act will become law on July 1, 2002, contingent on HB 1075, or similar legislation becoming law.

B. PRESENT SITUATION:

Pursuant to s. 19, Article III of the State Constitution, no trust fund of the State of Florida or other public body may be created by law without a three-fifths vote of the membership of each house of the legislature in a separate bill for the purpose of creating a trust fund only.

C. EFFECT OF PROPOSED CHANGES:

This bill creates the Rural Lands Program Trust Fund. The Rural Lands Program Trust Fund will be used by the Department of Agriculture and Consumer Services as a depository for funds pursuant to s. 201.15(1)(c), F.S., to pay debt service on bonds for rural land protection. (see HB 1075). Proceeds from the sale of these bonds are to be distributed into the Conservation and Recreation Lands Program Trust Fund to implement the Rural and Family Lands Protection Act pursuant to 570.71(12), F.S..

The bill further provides that any balance in the trust fund at the end of a fiscal year shall remain in the trust fund and will be available for carrying out the trust fund purposes. Also, in accordance with s. 19(f)(2), Article III of the State Constitution the bill terminates the trust fund on July 1, 2006, unless terminated sooner. Prior to the trust funds termination it shall be reviewed as provided in ss. 215.3206(1) and (2), F.S.

D. SECTION-BY-SECTION ANALYSIS:

Section 1: Creates the Rural Lands Program Trust Fund within the Department of Agriculture and Consumer Services; provides purpose and uses of the fund; provides termination by July 1, 2006, and provides for review as provided in ss. 215.3206(1) and (2), Florida Statutes.

Section: Provides an effective date of July 1, 2002, contingent upon the adoption of HB 1075 related to rural land protection.
