## I. SUMMARY:

The Florida Board of Education has established a procedure for the naming of buildings and facilities at the 10 state universities. Each university's Board of Trustees must first approve of the particular naming designation, and then the Florida Board of Education must also give its approval.

Current law does not permit a state building, road, bridge, park, recreational complex, or similar facility to be named after a living person unless the name designation in approved by law. Therefore, if a university desires a particular building or facility to be named after a living person, after initial approval by the Board of Trustees and the Florida Board of Education, the designation must be approved by the Legislature.

This act permits University of Florida, Florida Agricultural and Mechanical University, University of Central Florida, Florida Gulf Coast University, Palmer Campus of New College, and Florida Atlantic University to name certain buildings and/or facilities on their respective campuses.

This act does not appear to have a fiscal impact on state or local government.

An amendment was adopted by the Committee on State Administration which is traveling with the bill. Please see the "Amendments and Committee Substitute Changes" section for further discussion.

# B. PRESENT SITUATION:

Any university name designation must first be approved by the Board of Trustees of each separate university. Following this approval, the name designation must be approved by the Florida Board of Education. Section 267.062, F.S., provides that no state building, road, bridge, park, recreational complex, or similar facility can be named after a living person unless approved by law. Therefore, if a university desires a particular building or facility to be named after a living person, after initial approval by the university's Board of Trustees and the Florida Board of Education, the designation must be approved by the Legislature.<sup>1</sup>

# C. EFFECT OF PROPOSED CHANGES:

This act designates the:

- Renovated transplant housing unit at the University of Florida's Shands Hospital as the "Gerold L. Schiebler/Shands Transplant Housing Complex;"
- School of Business and Industry building at Florida Agricultural and Mechanical University as the "Sybil C. Mobley Business Building;"
- New allied health building at Florida Agricultural and Mechanical University as the "Jacqueline B. Beck-Margaret W. Lewis Allied Health Building;"
- Architecture building at Florida Agricultural and Mechanical University as the "Walter L. Smith Architecture Building;"
- Building which houses the University of Central Florida Downtown Center as the "James and Annie Ying Academic Center;"
- Student/community educational facility for health at Florida Gulf Coast University as the "Kleist Health Education Center;"

New gymnasium/athletics facility at Florida Gulf Coast University as the "Alico Arena;"

- New demonstration and educational model building to promote environmentally sustainable living conditions at Florida Gulf Coast University as the "WCI Green Building Demonstration and Learning Center;"
- New foundation building to be erected on the Palmer Campus of New College as the "Keating Center;" and
- New nursing building on the Boca Raton Campus of Florida Atlantic University as the "Christine E. Lynn Nursing Building."

All of these naming designations were approved by each university's Board of Trustees and the Florida Board of Education.<sup>2</sup>

#### D. SECTION-BY-SECTION ANALYSIS:

The biographical information in this section was provided by the sponsor of this legislation.

**Section 1:** Designates the renovated transplant housing unit at the University of Florida's Shands Hospital as the "Gerold L. Schiebler/Shands Transplant Housing Complex."

An anonymous donor contributed approximately \$600,000 cash and in-kind gifts to renovate the transplant housing unit at Shands Hospital. This donor wishes to name the renovated facility in honor of **Dr. Gerold L. Schiebler.** Dr. Schiebler has served the University of Florida and the State of Florida for more than 40 years. During that time he initiated several programs to improve the health and lives of children and high-risk pregnant women. Dr. Schiebler has received multiple honors and awards for his dedication to Florida's children.

<u>Section 2:</u> Designates the School of Business and Industry building at Florida Agricultural and Mechanical University (FAMU) as the "Sybil C. Mobley Business Building."

**Dean Mobley** has served FAMU for more than two decades and is the founding dean of the FAMU School of Business and Industry. Under her leadership the School of Business and Industry has prepared minority students to compete internationally in the world of business.

<u>Section 3:</u> Designates the new allied health building at Florida Agricultural and Mechanical University as the "Jacqueline B. Beck-Margaret W. Lewis Allied Health Building."

As Dean of the FAMU School of Nursing, **Dr. Lewis** has molded, shaped and nurtured the university's nursing program for more than 13 years. **Jacqueline B. Beck** has the distinction of being the founder and first Dean of the FAMU School of Allied Health Sciences. Dean Beck has been vigilant in expanding the school's programs and has worked to secure funding for research and academic programs from federal, state, and local sources totaling more than \$13 million as of the year 2000.

<u>Section 4:</u> Designates the architecture building at Florida Agricultural and Mechanical University as the "Walter L. Smith Architecture Building."

**Dr. Smith** served from 1977 to 1985 as FAMU's seventh president. Under his leadership and vision, FAMU was granted authority to offer its first Doctorate of Philosophy degree, was instrumental in the merging of the FAMU/FSU College of Engineering, and developed the statewide Conference on the Education of Blacks, which resulted in the Florida Legislature developing and funding the Florida Statewide Advisory Committee on the Education of Blacks.

<u>Section 5:</u> Designates the building which houses the University of Central Florida (UCF) Downtown Center as the "James and Annie Ying Academic Center."

In recognition of a significant gift made in 2001 by Dr. Nelson Ying, it is proposed that the building which houses the UCF Downtown Center be named the **James and Annie Ying Academic Center**, after Dr. Ying's parents. Dr. Ying has supported UCF over the past several years with contributions to multiple scholarships and programs. Dr. Ying has served two terms as a member of the Board of Directors of the UCF Foundation and is now an emeritus member of that Board.

<u>Section 6:</u> Designates the student/community educational facility for health at Florida Gulf Coast University as the "Kleist Health Education Center."

**The Kleists** are residents of Fort Myers, Florida, and have been generous benefactors of higher education throughout the United Stated for many years. The Kleists, through the Peter D. and Eleanore A. Kleist Foundation, are providing \$1 million for the center.

<u>Section 7:</u> Designates the new gymnasium/athletics facility at Florida Gulf Coast University (FGCU) as the "Alico Arena."

Under the leadership of Ben Hill Griffin III, **Alico, Inc.** donated 760 acres for the campus site, a 215-acre land endowment and funding for road construction, and academic chairs for the state's tenth university. Alico, Inc. is now providing \$2 million for an enhanced addition to the gymnasium floor plan to include additional seating and academic space for instructional programs. In addition, another \$1.5 million will support operations for the FGCU athletics program, and another \$1.5 million will provide scholarships for FGCU students bringing the total commitment to \$5 million.

<u>Section 8:</u> Designates the new demonstration and educational model building to promote environmentally sustainable living conditions at FGCU as the "WCI Green Building Demonstration and Learning Center."

The WCI Green Building Demonstration and Learning Center will be used as a demonstration and education model building to promote environmentally sustainable living conditions. **WCI Communities** has provided the lead gift of \$350,000 for the \$1,000,000 center.

<u>Section 9:</u> Designates the new foundation building to be erected on the Palmer Campus of New College as the "Keating Center."

The New College Foundation building to be erected on the Palmer Campus of New College of Florida is to be named the Keating Center in honor of **Edward and Elaine Keating** who have been generous contributors to the New College Foundation since 1986. The Keating's philanthropy has generously supported many community and charitable organizations within the Sarasota area.

<u>Section 10:</u> Designates the new nursing building on the Boca Raton Campus of Florida Atlantic University (FAU) as the "Christine E. Lynn Nursing Building."

**Mrs. Lynn** has gifted Florida Atlantic University with \$10 million to be used for a new nursing building and a program endowment. Mrs. Lynn and her late husband, E.M. Lynch, are generous philanthropists who previously donated \$2.5 million to FAU.
