14	Section 1. Section 627.4302, Florida Statutes, is
15	created to read:

17	<pre>prescription drug claims</pre>
18	(1) The purpose of this section is to improve patient
19	care by minimizing confusion, eliminating unnecessary work,
20	decreasing patient wait time, and improving business
21	efficiencies.
22	(2) Any health insurer or health maintenance
23	organization and all state and local government entities
24	entering into an agreement to provide coverage for
25	prescription drugs on an outpatient basis shall provide a
26	benefits-identification card containing the following
27	information:
28	(a) The name of the claim processor.
29	(b) The electronic-claims payor identification number
30	or the issuer identification number, also referred to as the
31	

1	Banking Identification Number or "BIN," assigned by the
2	American National Standards Institute.
3	(c) The insured's prescription group number.
4	(d) The insured's identification number.
5	(e) The insured's name.
6	(f) The claims submission name and address.
7	(g) The help desk telephone number.
8	(h) Any other information that the entity finds will
9	assist in the processing of the claim.
10	
11	The information required in paragraphs (a), (b), (g), and (h)
12	must be provided on the card, unless instruction is provided
13	on the card for ready access to such information by electronic
14	means.
15	(3) The benefits-identification card must present the
16	information in a manner readily identifiable or,
17	alternatively, the information may be embedded in the card and
18	available through magnetic stripe or smart card. The
19	information may also be provided through other electronic
20	technology.
21	(4) Any entity providing a
22	health-benefits-identification card containing all of the
23	information required by this section shall not be required to
24	provide a separate identification card for prescription drug
25	benefits.
26	(5) A benefits-identification card required under
27	subsection (2) shall be issued no later than 60 days after any
28	change in the information contained on the card becomes
29	effective. An entity may issue a temporary sticker containing
30	the new information in lieu of issuing a new card prior to the
31	

annual renewal date. Such sticker must be designed so that it can be attached to the existing card. Section 2. This act shall take effect October 1, 2002, and shall apply to policies or contracts issued or renewed on or after that date. STATEMENT OF SUBSTANTIAL CHANGES CONTAINED IN COMMITTEE SUBSTITUTE FOR CS for Senate Bill 1412 CS/CS/1412 allows use of the electronic claims payor identification number on the benefits-identification card; allows some of the required information to be omitted from the card if instruction is provided for ready access to such information by electronic means; and allows all entities to issue temporary stickers containing the required information if a change occurs prior to the annual renewal date.
