I. SUMMARY:

This legislation re-creates the Motor Vehicle Warranty Trust Fund, FLAIR number 412492, without modification. The Motor Vehicle Warranty Trust Fund is administered by the Department of Legal Affairs.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 681.117 and 681.110, F.S..

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The receipts of the Motor Vehicle Warranty Trust Fund are expended for the administration and coordination of the Florida New Motor Vehicle Arbitration Board.

For the 2001-2002 fiscal year, the Legislature appropriated \$1,824,578.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary source of revenue is a \$2 charge on the sale or lease of motor vehicles, which is collected and enforced by the Department of Revenue. One-fourth of the money received by the Department of Legal Affairs is transferred to the Division of Consumer Service of the Department of Agriculture and Consumer Services to carry out the provisions of lemon law dispute settlement (s. 681.108 and 681.109, F.S.). Total receipts from these charges in the 2000-2001 fiscal year were \$2,604,401. Agency estimates for the 2001-2002 fiscal year and the 2002-2003 fiscal year are \$2,790,658 and \$2,932,249, respectively.
