## I. SUMMARY:

This legislation re-creates the Grants and Donations Trust Fund, FLAIR number 802339, without modification. The Grants and Donations Trust Fund is administered by the Department of Juvenile Justice.

The trust fund is not in statute.

#### 2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The Grants and Donations Trust Fund was established to capture all revenues and expenditures for federal Department of Justice grants, county grants, and miscellaneous grant funds and fees received in the Department of Juvenile Justice.

For the 2001-2002 fiscal year, the Legislature appropriated \$39,232,093.

### MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary source of revenue is various grants, predominantly from the Federal Government.

Total receipts for the 2000-2001 fiscal year were \$92,515,358. Agency estimates for the 2001-2002 fiscal year and the 2002-2003 fiscal year are \$33,977,165 and \$65,889,879, respectively.

# B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
