### I. SUMMARY:

This legislation re-creates the Juvenile Justice Training Trust Fund, FLAIR number 802417, without modification. The Juvenile Justice Training Trust Fund is administered by the Department of Juvenile Justice.

### II. SUBSTANTIVE ANALYSIS:

### A. PRESENT SITUATION:

#### MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 985.406, F.S., creates the trust fund and provides for its purpose.

## 2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The Juvenile Justice Training Trust Fund is used to fund the development and implementation of job-related training programs for juvenile justice personnel.

For the 2001-2002 fiscal year, the Legislature appropriated \$2,888,066.

### MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary source of revenue for the Juvenile Justice Training Trust Fund are transfers from the Department of Highway Safety and Motor Vehicles. Total receipts from these funds for the 2000-2001 year were \$2,429,870. Agency estimates from a \$1.00 fee added to non-criminal traffic infractions and federal funds under Title IV-A for the 2001-2002 fiscal year and the 2002-2003 fiscal year are \$2,164,358 and \$2,164,358, respectively.

#### B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
