> A joint resolution of apportionment; providing for the apportionment of the Florida Senate (plan H407S002); adopting the United States Decennial Census of 2000 for use in such apportionment; providing for omitted areas; providing contiguity for areas specified for inclusion in one district which are entirely surrounded by other districts; providing severability of invalid portions; providing for application beginning in 2002 .

Be It Resolved by the Legislature of the State of Florida:

Section 1. Official census for apportionment;
definitions.--
(1) In accordance with s. 8(a), Art. X of the State Constitution, the United States Decennial Census of 2000 is the official census of the state for the purposes of this joint resolution.
(2) The following delineation of areas to be included in each senatorial district employs the official census county divisions, tracts, block numbering areas, block groups, and blocks used by the United States Department of Commerce, Bureau of the Census, in compiling the United States Decennial Census of 2000 in this state. The populations within these census geographic units are the population figures reported in the counts of the United States Decennial Census of 2000 provided to the state in accordance with Pub. L. No. 94-171.
(3) As used in this joint resolution, the term:

(a) "Block" means the smallest geographic unit for which population was ascertained in taking the 2000 census.
(b) "Block group" means the combination of blocks within a single tract or block numbering area the numbers of which begin with the same digit.
(c) "Tract" means the combination of blocks within a county which is delineated as a tract by local committee according to Census Bureau guidelines.
(d) "Block numbering area" or "BNA" means the combination of blocks within a county which are not included in a tract.
(e) "Census county division" means an administrative division of a county which contains tracts or block numbering areas.

Section 2. Senatorial districts.--For the election of members to the Senate of this state, the state is divided into 40 consecutively numbered, single-member, senatorial districts of contiguous territory. The state is apportioned into senatorial districts as follows:
