I. Summary:

This bill transfers the administration of s. 860.20, F.S., relating to the placement of serial numbers on outboard motors, from the Department of Environmental Protection to the Department of Highway Safety and Motor Vehicles.

This bill amends s. 860.20, F.S.

II. Present Situation:

Section 860.20, F.S., requires the Department of Environmental Protection (DEP) to adopt rules specifying the locations and manner in which serial numbers must be affixed to outboard motors. This section also requires the DEP's Division of Law Enforcement to issue a replacement identifying serial number for an outboard motor when ordered to do so by the court, if such numbers do not exist or have been somehow removed or altered.

Pursuant to ch. 328, F.S., the Department of Highway Safety and Motor Vehicles (DHSMV) is responsible for the registration and titling of vessels. This responsibility was transferred to the DHSMV from the DEP in 1995.

When the 1999 Legislature created the Fish and Wildlife Conservation Commission (FWC) it transferred some elements of the DEP to the FWC, including the responsibility for marine life, boating safety, and marine law enforcement. At the time of this transfer of functions, it appears that the issue of the most appropriate placement of the responsibilities relating to outboard motor serial numbers should have been addressed. It was not, however, and the DEP remains responsible for a vestige of its former marine law enforcement program. This bill transfers the

responsibility to the DHSMV where it would be appropriately placed in the agency that maintains vessel registration and titling information.

III. Effect of Proposed Changes:

Section 860.20, F.S., is amended to require the DHSMV to adopt rules specifying the location and manner in which serial numbers for outboard motors must be affixed. The DHSMV is also required by this section to issue replacement serial numbers for outboard motors when directed to do so by a court.
