Subsection (21) of section 316.003, Florida 12 13 Statutes, is amended, and subsection (82) is added to that 14 section, to read: 15 316.003 Definitions.--The following words and phrases, 16 when used in this chapter, shall have the meanings 17 respectively ascribed to them in this section, except where 18 the context otherwise requires: 19 (21) MOTOR VEHICLE. -- Any self-propelled vehicle not 20 operated upon rails or guideway, but not including any bicycle, electric personal assistive mobility device, or 21 22 moped. 23 (82) ELECTRIC PERSONAL ASSISTIVE MOBILITY DEVICE. -- Any 24 self-balancing, two non-tandem wheeled device, designed to transport only one person, with an electric propulsion system 25 26 with average power of 750 watts (1 h.p.), the maximum speed of 27 which, on a paved level surface when powered solely by such a 28 propulsion system while being ridden by an operator who weighs 29 170 pounds, is less than 20 mph. Electric personal assistive 30 mobility devices are not vehicles as defined in this section. 31

Section 316.2068, Florida Statutes, is 2 created to read: 3 316.2068 Electric personal assistive mobility devices; 4 regulations. --5 (1) An electric personal assistive mobility device, as б defined in s. 316.003, may be operated: 7 (a) On a road or street where the posted speed limit 8 is 25 miles per hour or less. 9 (b) On a marked bicycle path. 10 (c) On any street or road where bicycles are 11 permitted. (d) At an intersection, to cross a road or street even 12 if the road or street has a posted speed limit of more than 25 13 14 miles per hour. On a sidewalk if the person operating the device 15 (d) yields the right-of-way to pedestrians and gives an audible 16 17 signal before overtaking and passing a pedestrian. (2) A valid driver's license is not a prerequisite to 18 19 operating an electric personal assistive mobility device. 20 Electric personal assistive mobility devices need (3) 21 not be registered and insured in accordance with s. 320.02. 22 (4) A person who is under the age of 16 years may not operate, ride, or otherwise be propelled on an electric 23 24 personal assistive mobility device unless the person wears a 25 bicycle helmet that is properly fitted, that is fastened securely upon his or her head by a strap, and that meets the 26 27 standards of the American National Standards Institute (ANSI Z Bicycle Helmet Standards), the standards of the Snell Memorial 28 29 Foundation (1984 Standard for Protective Headgear for Use in 30 Bicycling), or any other nationally recognized standards for 31 bicycle helmets which are adopted by the department.

(7) A county or municipality may prohibit the operation of electric personal assistive mobility devices on any road, street, or bicycle path under its jurisdiction if the governing body of the county or municipality determines that such a prohibition is necessary in the interest of б safe<u>ty.</u> (8) The Department of Transportation may prohibit the operation of electric personal assistive mobility devices on any road under its jurisdiction if it determines that such a prohibition is necessary in the interest of safety. Section 3. This act shall take effect upon becoming a law. SENATE SUMMARY Regulates the use of electric personal assistive mobility devices, as defined in this act.
