#### I. SUMMARY:

Section 334.071, F.S., explains the process for the Legislature to designate roads, bridges and other transportation facilities for honorary or memorial purposes only.

HB 485 proposes designating that portion of State Road 580 within the Temple Terrace city limits, from the intersection of 52<sup>nd</sup> Street and Overlook Drive, through 56<sup>th</sup> Street, the "Temple Terrace Parkway."

The Florida Department of Transportation (DOT) is directed to erect suitable markers noting the designation, at an estimated minimum cost of \$500.

HB 485 takes effect upon becoming a law.

#### B. PRESENT SITUATION:

Section 334.071, F.S., explains the process for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not erase the current names of the facilities, nor do they require local governments and private entities to change street signs or addresses. Some public roads and bridges have multiple or overlapping designations.

Based on DOT records, 969 honorary road and bridge designations have been approved since 1922, most of them by the Legislature.

Some roads, however, have been officially named by the Legislature. For example, chapter 67-789, Laws of Florida, named a portion of State Road 580 in Hillsborough County, from Florida Avenue to 56<sup>th</sup> Street, "August A. Busch, Jr. Boulevard" in honor of the beer magnate who developed the Busch Gardens theme park along that state road.

#### C. EFFECT OF PROPOSED CHANGES:

HB 485 proposes designating that portion of State Road 580 within the Temple Terrace city limits, from the intersection of 52<sup>nd</sup> Street and Overlook Drive, through 56<sup>th</sup> Street, the "Temple Terrace Parkway."

#### D. SECTION-BY-SECTION ANALYSIS:

**Section 1:** Designates a portion of State Road 580 within the City of Temple Terrace as the "Temple Terrace Parkway." Directs DOT to erect suitable markers.

**Section 2:** Specifies this act shall take effect upon becoming a law.

DOT expects initially to incur an estimated cost of \$500 to implement the bill. Production and installation costs are estimated at \$250 per marker, and each designated road gets two markers. DOT also expects indeterminate recurring costs of maintaining these signs and replacing them, over time.

Based on conversations with the bill sponsor's legislative staff, HB 485 as drafted does not accomplish the sponsor's intent, which is to officially change the name of that portion of State Road

580 now known as Busch Boulevard within the Temple Terrace city limits to "Temple Terrace Parkway." An official renaming of that four-block stretch of road would entail changes in addresses for homeowners and businesses, as well as require the installation of new street signs at a cost considerably higher than \$500.

The bill sponsor plans to file an amendment to clarify her intent.

The City of Temple Terrace supports the official renaming of State Road 580/Busch Boulevard. In addition, the staff of DOT's District 7, which includes Temple Terrace, has agreed to work with city officials to implement the bill if it becomes law. At this point, it is unknown whether DOT would share costs with Temple Terrace.
