## I. Summary:

This bill provides for the issuance of a Pearl Harbor Survivor or Purple Heart license plate to certain disabled veterans without payment of the required license tax. The bill also increases the license tax distribution to the Grants and Donations Trust Fund of the Department of Veterans Affairs from $\$ 50,000$ to $\$ 100,000$ beginning in fiscal year 2002-03

The bill changes from January 1, 1997 to October 1, 2002, the date by which any collegiate license plate created or established after, must comply with the requirements of s. 320.08053.

This bill substantially amends section 320.089 of the Florida Statutes.

## II. Present Situation:

Currently, s. 320.089(1)(a), F.S., provides that Florida residents who are active duty or retired National Guard members, active duty U.S. Armed Forces Reservists, former Prisoners of War (POW), or Pearl Harbor Survivors and Purple Heart recipients, may purchase license plates having their military affiliation stamped on the license plate in the following manner: "National Guard", "Pearl Harbor Survivor", "Combat-Wounded Veteran, "U.S. Reserve", and "Purple Heart". The cost to these purchasers includes the fees as established in ss. 320.06 and 320.08, F.S. Paragraph (b) provides that beginning in fiscal year 2000-01 and annually thereafter, the first $\$ 50,000$ of revenue generated from the sale of such license plates shall be deposited into the Grants and Donations Trust Fund of the Department of Veterans Affairs, to be used pursuant to s. 296.38(2), F.S., for the common benefit of the residents of the Veterans Nursing Home of

Florida. The remaining funds are deposited into the Department of Transportation Primary Trust Fund.

Section 320.084, F.S., allows for one free motor vehicle license plate to be issued to disabled veterans who have been a resident of the state for the last 5 years and who were honorably discharged from the United States Armed Forces. At the time of application, the applicant must present proof that his or her vehicle was acquired through financial assistance by the Department of Veterans Affairs and they have a 100 percent service connected disability rating.

Subsection (3) of s. 320.08058 , F.S., directs the DHSMV to develop a collegiate license plate for state and independent universities domiciled in Florida. Any collegiate license plate created or established after January 1, 1997, must comply with the requirements of s. 320.08053 and be specifically authorized by an act of the Legislature.

## III. Effect of Proposed Changes:

This bill amends s. 320.089 , F.S., to provide for the issuance of a Pearl Harbor Survivor or Purple Heart motor vehicle license plate, without payment of the license tax imposed by s. 320.08 , F.S, to a person who also qualifies for a disabled veteran's license plate under s. 320.084 , F.S. There shall be a $\$ 2.50$ service charge retained by the Tax Collector in accordance with the provisions of s. 320.04 , F.S, for each initial application or renewal of registration and a fifty cent retro reflective materials fee for the license plate as provided in s. 320.06(3)(b), F.S. Registration under this section shall be renewed annually during the applicable renewal period on forms prescribed by the Department of Highway Safety and Motor Vehicles.

The bill also amends paragraph (b) of s. 320.089 , F.S., increasing the license tax distribution to the Grants and Donations Trust Fund of the Department of Veterans Affairs from \$50,000 to $\$ 100,000$ beginning in fiscal year 2002-03.

The bill also amends subsection (3) of s. 320.08058, F.S., changing from January 1, 1997 to October 1, 2002, the date by which any collegiate license plate created or established after, must comply with the requirements of s. 320.0805 and be specifically authorized by an act of the Legislature.

The bill shall take effect July 1, 2002.

## V. Economic Impact and Fiscal Note:

A. Tax/Fee Issues:

The bill provides for the issuance of a Pearl Harbor Survivor or Purple Heart motor vehicle license plate, without payment of the license tax imposed by s. 320.08 , F.S, to a person who also qualifies for a disabled veteran's license plate under s. 320.084, F.S. In addition, the bill increases the license tax distribution to the Grants and Donations Trust Fund of the Department of Veterans Affairs from $\$ 50,000$ to $\$ 100,000$ beginning in fiscal year 2002-03.

According to the Department of Highway Safety and Motor Vehicles, there are approximately 12,000 disabled veteran license plates in circulation. The chart below shows the number of Pearl Harbor, Purple Heart, National Guard and U.S. Reserve license plates issued annually from October 1, 1999 through fiscal year 2000-01. If all of the 12,000 disabled veteran license plates qualified for a free Pearl Harbor or Purple Heart license plate, the maximum annual loss to the State Transportation Trust Fund would be an estimated $\$ 324,000$ based on fiscal year 2000-01 data. Based on total collections of $\$ 483,511$ for fiscal year 2000-01, the Grants and Donations Trust Fund of the Department of Veterans' Affairs would not loose any revenue since the trust fund would receive the first $\$ 100,000$ of revenue collected from such license plates. It is very unlikely that all of the 12,000 disabled veteran license plate recipients would qualify for either a Pearl Harbor or Purple Heart license plate.

The amendment to s. 320.08058 (3), F.S., will allow New College in Sarasota to develop a collegiate license plate prior to October 1, 2002, without complying with the requirements of s. 320.08053 and being authorized by an act of the Legislature. Persons electing to purchase a New College license plate would pay the $\$ 25$ annual use fee, the proceeds of which will be distributed to New College.
B. Private Sector Impact:

Pearl Harbor Survivor or Purple Heart license plate recipients who qualify for a disabled veteran's license plate would not pay an annual license tax fee as provided for in s. 320.08 , F.S. The average savings to each Pearl Harbor or Purple Heart license plate recipient would be $\$ 27.00$.
C. Government Sector Impact:

The distribution to the Department of Veterans Affairs from the sale of "National Guard", "Pearl Harbor Survivor", "Combat-Wounded Veteran, "U.S. Reserve", and "Purple Heart" license plates will increase by $\$ 50,000$. The money is used for the common benefit of the residents of the Veterans Nursing Home of Florida. Deposits into the Department of Transportation Primary Trust Fund would decline by $\$ 50,000$.

The Department estimates the bill will require $\$ 7,560$ for contracted programming modifications to the Motor Vehicles Software System.

The Department will absorb the cost of developing and producing the New College license plate.
