18	(1)(a) Each owner or lessee of an automobile or truck
19	for private use or recreational vehicle as specified in s.
20	320.08(9)(c) or (d), which is not used for hire or commercial
21	use, who is a resident of the state and an active or retired
22	member of the Florida National Guard, a survivor of the attack
23	on Pearl Harbor, a recipient of the Purple Heart medal, or an
24	active member of any branch of the United States Armed Forces
25	Reserve shall, upon application to the department, accompanied
26	by proof of active membership or retired status in the Florida

license tax for the vehicle as provided in s. 320.08, be 1 2 issued a license plate as provided by s. 320.06, upon which, 3 in lieu of the serial numbers prescribed by s. 320.06, shall be stamped the words "National Guard," "Pearl Harbor 4 5 Survivor, " "Combat-wounded veteran, " or "U.S. Reserve," as б appropriate, followed by the serial number of the license 7 plate. Additionally, the Purple Heart plate may have the words 8 "Purple Heart" stamped on the plate and the likeness of the 9 Purple Heart medal appearing on the plate. 10 (b) Notwithstanding any other provision of law to the 11 contrary beginning with fiscal year 2000-2001 and annually thereafter, the first \$50,000 in general revenue generated 12 13 from the sale of license plates issued under this section which are stamped with the words "National Guard," "Pearl 14 Harbor Survivor, "Combat-wounded veteran, "or "U.S. Reserve" 15 shall be deposited into the Grants and Donations Trust Fund, 16 17 as described in s. 296.38(2), to be used for the purposes 18 established by law for that trust fund. 19 (c) Notwithstanding any provisions of law to the contrary, an applicant for a Pearl Harbor Survivor license 20 plate or a Purple Heart license plate who also qualifies for a 21 22 disabled veteran's license plate under s. 320.084 shall be issued the appropriate special license plate without payment 23 24 of the license tax imposed by s. 320.08. 25 (2) Each owner or lessee of an automobile for private use, truck weighing not more than 5,000 pounds, or 26 recreational vehicle as specified in s. 320.08(9)(c) or (d), 27 28 which is not used for hire or commercial use, who is a 29 resident of the state and who is a former prisoner of war, or their unremarried surviving spouse, shall, upon application 30 31 therefor to the department, be issued a license plate as

1 provided in s. 320.06, on which license plate are stamped the 2 words "Ex-POW" followed by the serial number. Each application 3 shall be accompanied by proof that the applicant meets the 4 qualifications specified in paragraph (a) or paragraph (b). 5 (a) A citizen of the United States who served as a 6 member of the Armed Forces of the United States or the armed 7 former of a method with the United States who were held

7 forces of a nation allied with the United States who was held 8 as a prisoner of war at such time as the Armed Forces of the 9 United States were engaged in combat, or their unremarried 10 surviving spouse, may be issued the special license plate 11 provided for in this subsection without payment of the license 12 tax imposed by s. 320.08.

13 (b) A person who was serving as a civilian with the consent of the United States Government, or a person who was a 14 member of the Armed Forces of the United States who was not a 15 United States citizen and was held as a prisoner of war when 16 17 the Armed Forces of the United States were engaged in combat, 18 or their unremarried surviving spouse, may be issued the 19 special license plate provided for in this subsection upon 20 payment of the license tax imposed by s. 320.08.

(3) Each owner or lessee of an automobile for private 21 22 use, truck weighing not more than 5,000 pounds, or recreational vehicle as specified in s. 320.08(9)(c) or (d), 23 24 which is not used for hire or commercial use, who is a 25 resident of this state and who is the unremarried surviving spouse of a recipient of the Purple Heart medal shall, upon 26 27 application therefor to the department, with the payment of 28 the required fees, be issued a license plate as provided in s. 29 320.06, on which license plate are stamped the words "Purple Heart" and the likeness of the Purple Heart medal followed by 30 the serial number. Each application shall be accompanied by 31

proof that the applicant is the unremarried surviving spouse of a recipient of the Purple Heart medal. Section 2. This act shall take effect July 1, 2002. б SENATE SUMMARY Provides for certain disabled veterans to be issued a Purple Heart license plate or a Pearl Harbor Survivor license plate without paying the required license tax.
