certification of the signature to the Secretary of State, 1 2 provided all other requirements of law are satisfied complied 3 with. 4 (3) The sponsor of an initiative amendment shall, 5 prior to obtaining any signatures, register as a political committee pursuant to s. 106.03 and submit the text of the 6 7 proposed amendment to the Secretary of State, with the form on which the signatures will be affixed, and shall obtain the 8 9 approval of the Secretary of State of such form. The 10 Secretary of State shall adopt promulgate rules pursuant to ss. 120.536(1) and s.120.54 prescribing the style and 11 12 requirements of such form, including a requirement that the sponsor of the amendment indicate on the form if a person is 13 14 or will be paid to gather signatures. 15 (4) The sponsor shall, prior to obtaining any signatures, submit the initiative amendment to the Revenue 16 17 Estimating Conference for the purpose of determining its 18 estimated impact on state and local revenues and expenditures, if any. The Revenue Estimating Conference shall affix a 19 fiscal impact statement to the text that will be circulated to 20 21 obtain signatures. The Secretary of State shall adopt rules 22 pursuant to ss. 120.536(1) and 120.54 prescribing the style and requirements of such fiscal impact statement. 23 24 (5) (4) The sponsor shall, within 60 days after the 25 date of signing, or no later than 5 p.m. on the 180th day before the general election at which the proposed initiative 26 27 is to be voted on, whichever occurs earlier, submit signed and dated forms to the appropriate supervisor of elections for 28 29 verification as to the number of registered electors whose 30 valid signatures appear thereon. The supervisor shall 31 promptly verify the signatures upon payment of the fee

Upon completion of verification, the 1 2 supervisor shall execute a certificate indicating the total 3 number of signatures checked, the number of signatures 4 verified as valid and as being of registered electors, and the 5 distribution by congressional district. This certificate 6 shall be immediately transmitted to the Secretary of State. 7 The supervisor shall retain the signature forms for at least 1 year following the election in which the issue appeared on the 8 ballot or until the Division of Elections notifies the 9 supervisors of elections that the committee which circulated 10 the petition is no longer seeking to obtain ballot position. 11 12 (6)(5) The Secretary of State shall determine from the 13 verification certificates received from supervisors of elections the total number of verified valid signatures and 14 15 the distribution of such signatures by congressional 16 districts. Upon a determination that the requisite number and 17 distribution of valid signatures have been obtained, the secretary shall issue a certificate of ballot position for 18 that proposed amendment and shall assign a designating number 19 20 pursuant to s. 101.161. A petition shall be deemed to be filed with the Secretary of State upon the date of the receipt 21 by the secretary of a certificate or certificates from 22 supervisors of elections indicating the petition has been 23 24 signed by the constitutionally required number of electors. 25 (7) (7) (6) The Department of State may adopt rules pursuant to ss. 120.536(1) and shall have the authority to 26 27 promulgate rules in accordance with s.120.54 to carry out the 28 provisions of this section. 29 30 31
