I. SUMMARY:

For the 2001-2002 fiscal year, the bill appropriates \$875,000 from the General Revenue Fund to the Department of Agriculture and Consumer Services' Division of Animal Industry for construction of a biosafety level 3 (BSL3) biocontainment facility and upgrading biosafety measures at the Kissimmee Diagnostic Laboratory.

B. PRESENT SITUATION:

The Department of Agriculture and Consumer Services' animal diagnostic laboratory located in Kissimmee does not currently have a secure biocontainment facility adequate to safely handle agents of bioterrorism. To safely handle such agents, a biosafety level 3 (BL3) is required. Bioterrorism agents include diseases of humans and animals, toxins and chemicals. Certain foreign animal diseases, such as Foot and Mouth Disease (FMD) and Heartwater, could devastate Florida's animal populations and food supply if introduced either by deliberate acts of introduction or by slipping through inspections at the state's numerous international ports of entry.

C. EFFECT OF PROPOSED CHANGES:

For the 2001-2002 fiscal year, the bill appropriates \$875,000 from nonrecurring revenue of the General Revenue Fund to the Department of Agriculture and Consumer Services' Division of Animal Industry for construction of a biocontainment facility and upgrade of biosafety measures at the Kissimmee Diagnostic Laboratory.

Among others, specific modifications needed to take the Kissimmee Diagnostic Laboratory from a biosafety level 2 to a biosafety level 3 include reconstructing an inadequate ventilation system to provide for all air in the BL3 unit to be filtered (no recirculation), addition of proper waste disposal capabilities, and safe handling of agents and reagents with prescribed decontamination procedures.
