committee shall be governed by joint rules adopted by the 1 2 legislature no later than the 2003 regular session pursuant to 3 the authority to adopt rules under section 4 of this article. 4 Such rules shall establish a schedule for review of such exemptions and exclusions over a three-year period and shall 5 provide criteria to be considered by the committee in 6 7 conducting its review. No later than March 1 of 2004, 2005, 8 and 2006, the committee shall submit its findings and recommendations to the presiding officers of each house of the 9 10 legislature. Any decision to deauthorize an exemption or 11 exclusion must be approved by seven members of the committee 12 and shall be in the form of a resolution adopted by the 13 committee, which shall be submitted to the legislature. The resolution shall set forth the specific changes to the 14 15 statutes necessary to effectuate the deauthorization, which resolution shall have the force of law and shall become 16 17 effective July 1 following the second regular session 18 occurring after submission to the legislature, except for 19 those exemptions or exclusions expressly rescinded by joint resolution of the legislature prior to that date. This 20 section does not operate to deauthorize any exemption or 21 22 exclusion not expressly deauthorized in such resolution, nor does it prohibit subsequent reenactment by law of any 23 24 exemption or exclusion that was deauthorized. The joint 25 committee is dissolved July 1, 2006.
