22-2362-02 1 A bill to be entitled 2 An act relating to the Excellent Teaching 3 Program; creating ss. 1012.72, 1010.72, F.S.; 4 redesignating a program and trust fund as the 5 "Dale Hickam Excellent Teaching Program" and 6 the "Dale Hickam Excellent Teaching Program 7 Trust Fund"; repealing ss. 236.08106, 236.08107, F.S., relating to the Excellent 8 9 Teaching Program and the Excellent Teaching Program Trust Fund; providing for construction 10 of the act in pari materia with laws enacted 11 12 during the Regular Session of the Legislature; providing an effective date. 13 14 WHEREAS, Dale Hickam served the Florida Senate with 15 integrity and distinction for 22 years as a staff member of 16 17 its education appropriations committee, and WHEREAS, Dale Hickam supported the Legislature's 18 19 initiative and the decisionmaking process through a unique combination of skills, including meticulous attention to 20 21 detail, great personal warmth, and a vigorous approach to 22 difficult funding issues, and 23 WHEREAS, Dale Hickam was a skilled and beloved teacher who traveled all over the United States to lead seminars on 24 25 personal growth and relationship building, and WHEREAS, hundreds of Florida teachers and millions of 26 27 Florida students received the benefit of Dale Hickam's care 28 and expertise without knowing his name, and WHEREAS, the 1998 Legislature relied upon Dale Hickam's 29 30 research and ingenuity to create a program that has gained 31 national prominence for its improvements in the quality and 1 CODING: Words stricken are deletions; words underlined are additions.

    national voluntary system for assessing and certifying

    incentives for teachers to seek NBPTS certification and to

1 NBPTS an amount as prescribed annually by the Legislature for the Dale Hickam Excellent Teaching Program. For purposes of 2 3 this section, the Florida School for the Deaf and the Blind shall be considered a school district. Unless otherwise 4 5 provided in the General Appropriations Act, each distribution б shall be the sum of the amounts earned for the following 7 incentives and bonuses: 8 (a) A fee subsidy to be paid by the Department of Education to the NBPTS on behalf of each individual who is an 9 employee of a district school board or a public school within 10 11 the school district, who is certified by the district to have demonstrated satisfactory teaching performance pursuant to s. 12 1012.34 and who satisfies the prerequisites for participating 13 in the NBPTS certification program, and who agrees, in 14 writing, to pay 10 percent of the NBPTS participation fee and 15 to participate in the NBPTS certification program during the 16 17 school year for which the fee subsidy is provided. The fee subsidy for each eligible participant shall be an amount equal 18 19 to 90 percent of the fee charged for participating in the NBPTS certification program. The fee subsidy is a one-time 20 21 award and may not be duplicated for any individual. (b) A portfolio-preparation incentive of \$150 paid by 22 the Department of Education to each teacher employed by a 23 24 district school board or a public school within a school district who is participating in the NBPTS certification 25 program. The portfolio-preparation incentive is a one-time 26 27 award paid during the school year for which the NBPTS fee 28 subsidy is provided. 29 (c) An annual bonus equal to 10 percent of the prior 30 fiscal year's statewide average salary for classroom teachers 31 to be distributed to the school district to be paid to each 3

1 individual who holds NBPTS certification and is employed by the district school board or by a public school within the 2 3 school district. The district school board shall distribute the annual bonus to each individual who meets the requirements 4 5 of this paragraph and who is certified annually by the б district to have demonstrated satisfactory teaching 7 performance pursuant to s. 1012.34. The annual bonus may be 8 paid as a single payment or divided into not more than three 9 payments. 10 (d) An annual bonus equal to 10 percent of the prior 11 fiscal year's statewide average salary for classroom teachers to be distributed to the school district to be paid to each 12 individual who meets the requirements of paragraph (c) and 13 agrees, in writing, to provide the equivalent of 12 workdays 14 of mentoring and related services to public school teachers 15 within the state who do not hold NBPTS certification. The 16 17 district school board shall distribute the annual bonus in a single payment following the completion of all required 18 19 mentoring and related services for the year. It is not the intent of the Legislature to remove excellent teachers from 20 their assigned classrooms; therefore, credit may not be 21 granted by a school district or public school for mentoring or 22 related services provided during student contact time during 23 24 the 196 days of required service for the school year. 25 A teacher for whom the state pays the certification fee and 26 27 who does not complete the certification program or does not 28 teach in a public school of this state for at least 1 year 29 after completing the certification program must repay the 30 amount of the certification fee to the state. However, a 31 teacher who completes the certification program but fails to

1 be awarded NBPTS certification is not required to repay the amount of the certification fee if the teacher meets the 2 3 1-year teaching requirement. Repayment is not required of a teacher who does not complete the certification program or 4 5 fails to fulfill the teaching requirement because of the б teacher's death or disability or because of other extenuating circumstances as determined by the State Board of Education. 7 8 (3)(a) In addition to any other remedy available under 9 the law, any person who is a recipient of a certification fee subsidy paid to the NBPTS and who is an employee of the state 10 11 or any of its political subdivisions is considered to have consented, as a condition of employment, to the voluntary or 12 involuntary withholding of wages to repay to the state the 13 amount of such a certification fee subsidy awarded under this 14 section. Any such employee who defaults on the repayment of 15 such a certification fee subsidy must, within 60 days after 16 17 service of a notice of default by the Department of Education to the employee, establish a repayment schedule which must be 18 19 agreed to by the department and the employee, for repaying the defaulted sum through payroll deductions. The department may 20 not require the employee to pay more than 10 percent of the 21 employee's pay per pay period under such a repayment schedule 22 or plan. If the employee fails to establish a repayment 23 24 schedule within the specified period of time or fails to meet the terms and conditions of the agreed upon or approved 25 repayment schedule as authorized by this subsection, the 26 27 employee has breached an essential condition of employment and 28 is considered to have consented to the involuntary withholding of wages or salary for the repayment of the certification fee 29 30 subsidy. 31

1 (b) A person who is employed by the state, or any of its political subdivisions, may not be dismissed for having 2 3 defaulted on the repayment of the certification fee subsidy to 4 the state. 5 (4) The State Board of Education may adopt rules as б necessary to administer the provisions for payment of the fee 7 subsidies, incentives, and bonuses and for the repayment of 8 defaulted certification fee subsidies under this section. 9 Section 2. Section 1010.72, Florida Statutes, is 10 created to read: 11 1010.72 Dale Hickam Excellent Teaching Program Trust Fund.--The Dale Hickam Excellent Teaching Program Trust Fund 12 is created to be administered by the Department of Education. 13 Funds must be credited to the trust fund as provided in 14 chapter 98-309, Laws of Florida, to be used for the purposes 15 16 set forth therein. 17 Section 3. Section 236.08106, Florida Statutes, as amended by section 15 of chapter 2001-47, Laws of Florida, and 18 19 section 236.08107, Florida Statutes, are repealed. Section 4. If any law that is amended by this act was 20 also amended by a law enacted at the 2002 Regular Session of 21 the Legislature, such laws shall be construed as if they had 22 been enacted at the same session of the Legislature, and full 23 24 effect should be given to each if that is possible. 25 Section 5.
