SUMMARY ANALYSIS

This bill creates the Rural Lands Program Trust Fund within the Department of Agriculture and Consumer Services. The purpose of the trust fund is to receive funds and to pay debt service on bonds that are issued pursuant to s. 215.6195, F.S., which authorizes the issuance of bonds for rural land protection. It provides for the annual carryforward of funds and for future legislative review and termination or re-creation of the trust fund.

Pursuant to Article III, Section 19(f), Florida Constitution, no trust fund of the State of Florida or any public body may be created by law without a three-fifths vote of the membership of each house of the Legislature. Additionally, the bill creating the trust fund must be separate from any related substantive bill. HB 1111 is tied to HB 1101 relating to rural land protection.

This bill is contingent upon the Legislature passing HB 1101 for the acquisition of conservation easements, rural land protection easements, agricultural protection agreements and resource conservation agreements.
