#### **SUMMARY ANALYSIS**

The bill requires the Department of Children and Family Services to enter into working agreements related to the criminal investigation of adult abuse, neglect, and exploitation with local law enforcement agencies by September 1, 2003 and to evaluate the effectiveness of those agreements by September 1, 2004. The requirement for these agreements has been in the statutes since 2000. The requirements that they be in place by a specific date and that they be evaluated are new.

There is no fiscal impact. The bill takes effect July 1, 2003.

The department is required to review the efficacy of those agreements by September 1, 2004.

The Legislature added the requirement for these working agreements during the 2000 session; to date, however, the department has not executed agreements in all areas of the state.

Section 1 amends 415.1045(6) F.S. related to working agreements between the department and local law enforcement agencies.

Section 2 provides that the bill take effect on July 1, 2003.
