Corporation tax credits for salary paid to 18 19 military reservists while on active duty.--A corporation may 20 claim a credit against any corporate income tax liability or 21 sales tax liability in this state equal to any salary paid to 22 a military reservist while on active duty, as long as the salary claimed for such person is not greater than the salary 23 paid to such person prior to being called to active duty minus 24 25 the amount of the military reservist's active duty base pay and benefit package. In order to claim the credit, the 26 27 corporation shall provide documentation of the income and 28 military pay of such person. 29 Section 3.
