18	Be It Enacted by the Legislature of the State of Florida:

20	Section 1. As used in this act:
21	(1) "Board" means the Board of County Commissioners of
22	the county.
23	(2) "Clerk" means the Clerk of the Circuit Court of
24	the county.
25	(3) "County" means Hillsborough County, Florida.
26	(4) "Court" means the Thirteenth Judicial Circuit and
27	the civil division of the county court as may be reconfigured
28	from time to time.
29	(5) "Law library" means the James J. Lunsford Law
30	Library created by county ordinance adopted by the board.

1	Section 2. The maintenance and operation of the law
2	library is a public purpose.
3	Section 3. (1) Notwithstanding and in lieu of any
4	other provision of law, the board may annually establish by
5	ordinance a filing fee upon the institution of any action,
6	suit, or proceeding in each of the divisions of the courts,
7	which fee may vary by division but shall not exceed \$25 per
8	filing, for the purpose of maintaining and operating the law
9	library.
10	(2) Moneys collected and remitted in accordance with
11	this act and any county ordinance adopted by the board shall
12	be expended only for the purposes provided by this act. If
13	authorized by the board by ordinance, such moneys may be
14	expended for the following purposes ancillary to the
15	maintenance and operation of the law library:
16	(a) Payment to the clerk for services rendered.
17	(b) Payment to the county for administrative costs
18	relating to managing funds collected.
19	(c) Payment for any legal expenses of the law library.
20	(3) The party or parties instituting an action, suit,
21	or proceeding shall pay any such filing fee established
22	pursuant to this act and any county ordinance adopted by the
23	board. However, if a person is determined by a court to be
24	indigent, or if the filing fee is otherwise waived in
25	accordance with general law, the board may by ordinance
26	provide for the waiver of all or a portion of such filing fee.
27	(4) The clerk shall collect and maintain an accounting
28	of any filing fees established in accordance with this act and
29	any county ordinance and shall remit funds derived from any
30	such filing fees in accordance with any county ordinance
31	adopted by the board. The clerk may accept payment for

services rendered if authorized pursuant to subsection (2) and expend any such funds for the purposes required by that office. Section 4. If any provision of this act is determined to be unconstitutional or invalid, such determination shall б not affect the constitutionality or validity of any of the remaining provisions, and to this end the provisions of this act are declared severable. Section 5. Chapters 75-400 and 79-479, Laws of Florida, are repealed. Section 6. This act shall take effect October 1, 2003.
