### SUMMARY ANALYSIS

Section 334.071, F.S., specifies that the Legislature may designate roads, bridges and other transportation facilities for honorary or memorial purposes.

HB 555 designates portions of roadways within Miami-Dade County in honor of nine persons. They are:

- State Road 944 on N.W. 54<sup>th</sup> Street from the western boundary of State House District 108 to U.S. 1 is designated as "Jean-Jacques Dessalines Boulevard."
- State Road 922 on N.W. 125<sup>th</sup> Street from N.W. 7<sup>th</sup> Avenue to Griffing Boulevard is designated as "Toussaint L'Ouverture Boulevard."
- State Road 915 on N.E. 6<sup>th</sup> Avenue from the northern boundary of State House District 108 to U.S. 1 is designated as "Frederick Douglass Boulevard."
- State Road 909 on West Dixie Highway from the northern boundary of House District 108 to N.E. 2<sup>nd</sup> Avenue is designated as "Alexandre Petion Boulevard."
- Designates State Road 7 on N.W. 7<sup>th</sup> Avenue (U.S. 441), from the northern boundary of State House District 108 to its southern boundary, as "Lawton Chiles Boulevard."
- Designates State Road 5 on Biscayne Boulevard (U.S. 1), from the northern boundary of State House District 108 to its southern boundary, as "George Gill Boulevard."
- Designates State Road 932 on N.W. 103<sup>rd</sup> Street, from the western boundary of State House District 108 to N.E. 6<sup>th</sup> Avenue as "James Weldon Johnson Boulevard."
- Designates Northwest 183<sup>rd</sup> Street from Northwest 32<sup>nd</sup> Avenue to Northwest 47<sup>th</sup> Avenue as "T. Stewart Greer Boulevard."
- Designates that portion of State Road 922 (96<sup>th</sup> Street) that provides entry to and exit from the Bal Harbour Shops in Miami-Dade County, as "Stanley Whitman Boulevard."

The Florida Department of Transportation (FDOT) is directed to erect suitable markers at either end of each roadway to denote the honorary designations. The markers will cost FDOT approximately \$7,200.

HB 555 does not raise any apparent constitutional issues. It takes effect upon becoming a law.

#### B. EFFECT OF PROPOSED CHANGES:

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not erase the current names of the facilities, nor do they require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings. The statute requires FDOT to place a marker at each terminus or intersection of an identified road or bridge, and to erect any other markers it deems appropriate for the transportation facility.

Based on FDOT records, 969 honorary road and bridge designations have been approved since 1922, most of them by the Legislature. Some public roads and bridges have multiple or overlapping designations.

HB 555 adds nine more designations:

- State Road 944 on N.W. 54<sup>th</sup> Street from the western boundary of State House District 108 to U.S. 1 is designated as “Jean-Jacques Dessalines Boulevard.”
- State Road 922 on N.W. 125<sup>th</sup> Street from N.W. 7<sup>th</sup> Avenue to Griffing Boulevard is designated as “Toussaint L’Ouverture Boulevard.”
- State Road 915 on N.E. 6<sup>th</sup> Avenue from the northern boundary of State House District 108 to U.S. 1 is designated as “Frederick Douglass Boulevard.”
- State Road 909 on West Dixie Highway from the northern boundary of House District 108 to N.E. 2<sup>nd</sup> Avenue is designated as “Alexandre Petion Boulevard.”
- Designates State Road 7 on N.W. 7<sup>th</sup> Avenue (U.S. 441), from the northern boundary of State House District 108 to its southern boundary, as “Lawton Chiles Boulevard.”
- Designates State Road 5 on Biscayne Boulevard, from the northern boundary of State House District 108 to its southern boundary, as “George Gill Boulevard.”
- Designates State Road 932 on N.W. 103<sup>rd</sup> Street, from the western boundary of State House District 108 to N.E. 6<sup>th</sup> Avenue as “James Weldon Johnson Boulevard.”
- Designates Northwest 183<sup>rd</sup> Street from Northwest 32<sup>nd</sup> Avenue to Northwest 47<sup>th</sup> Avenue as “T.Stewart Greer Boulevard.”
- Designates that portion of State Road 922 ((6<sup>th</sup> Street) that provides entry to and exit from the Bal Harbour Shops in Miami-Dade County, as “Stanley Whitman Boulevard.”

The bill also directs FDOT to erect suitable markers conveying these designations.

HB 555 takes effect upon becoming a law.

**Section 9:** Creates honorary designation of a road in Miami-Dade County as "Stanley Whitman Boulevard."
