I. Summary:

Article III, Section 19(f) of the Florida Constitution requires the recreation of all agency trust funds every 4 years. The Legislature has placed executive branch agency funds on a staggered review cycle to facilitate the review and recreation. The Department of Education's funds, including the universities, are scheduled to terminate on November 4, 2004, unless specific action is taken for re-creation or finding of exemption. The Education Appropriations Committee has reviewed all education trust funds pursuant to the provisions of s. 215.3206, Florida Statutes. This bill terminates two trust funds within the Department of Education, Division of Colleges and Universities, and transfers current balances to the General Revenue Fund, unless otherwise specified.

In addition, this bill identifies seven trust funds within the Department of Education and thirteen trust funds within the Department of Education, Division of Colleges and Universities that have been determined to be exempt from the automatic termination provisions of Article III, Section 19(f) of the State Constitution.

This bill also renames three trust funds.

II. Present Situation:

Facilities Construction Administrative Trust Fund, FLAIR number 49-2-222:

This trust fund was formerly used for funding Board of Regents educational facilities staff in the Department of Education. Now all Department of Education educational

facilities staff are consolidated in one Office of Educational Facilities under the State Board of Education and this trust fund is no longer needed.

University of South Florida Medical Center Student Fee Trust Fund, FLAIR number 49-2-406:

In 2001-02 this trust fund had "0" revenues and "0" balance on 6-30-02. The Department of Education, Division of Colleges and Universities recommends this trust fund be terminated. It is largely duplicative of the Education and General Student and Other Fees Trust Fund, FLAIR number 49-2-164 which is recommended to be recreated for 4 additional years.

III. Effect of Proposed Changes:

This bill terminates the following trust funds within the Department of Education.

- Facilities Construction Administration Trust Fund, FLAIR number 49-2-222
- University of South Florida Medical Center Student Fee Trust Fund, FLAIR number 49-2-406

This bill identifies seven trust funds within the Department of Education and thirteen trust funds within the Division of Colleges and Universities that have been determined to be exempt from the automatic termination provisions of Article III, Section 19f of the State Constitution.
