11.2421 Florida Statutes 2004 2003 adopted.--The accompanying revision, consolidation, and compilation of the public statutes of 2003 2002 of a general and permanent nature, excepting tables, rules, indexes, and other related matter contained therein, prepared by the Office of Legislative Services under the provisions of s. 11.242, together with corrections, changes, and amendments to and repeals of provisions of Florida Statutes 2003 2002 enacted in additional reviser's bill or bills by the 2004 2003 Legislature, is adopted and enacted as the official statute law of the state under the title of "Florida Statutes 2004 2003" and shall take effect
