

| 16 | required fees and background investigation for a period of 1 |
| 17 | year subsequent to the date of retirement of said officer as a |
| 18 | law enforcement officer, a correctional officer, or a |
| 19 | correctional probation officer. |
| 20 | (c) A full set of fingerprints of the applicant |
| 21 | administered by a law enforcement agency. |
| 22 | (d) A photocopy of a certificate or an affidavit or |
| 23 | document as described in paragraph (2)(h). |
| 24 | (e) A full frontal view color photograph of the |
| 25 | applicant taken within the preceding 30 days, in which the |
| 26 | head, including hair, measures $7/8$ of an inch wide and $1 \ 1/8$ |
| 27 | inches high. |
| 28 | (f) In addition to the initial and renewal fees |
| 29 | provided in paragraph (b), a nonrefundable annual fee of \$5 |
| 30 | which shall be transferred monthly to the Shooting Range |
