Section 1003.429, Florida Statutes, is 16 17 amended to read: 1003.429 Accelerated high school graduation options.--18 19 Students who enter the 9th grade in the 2004-2005 20 school year Beginning with the 2003-2004 school year, all 21 students scheduled to graduate in 2004 and thereafter may 22 select one of the following three high school graduation 23 options: (a) Completion of the general requirements for high 24 25 school graduation pursuant to s. 1003.43; (b) Completion of a 3-year standard college 26 27 preparatory program requiring successful completion of a 28 minimum of 18 academic credits in grades 9 through 12. The 18 credits shall be primary requirements and shall be distributed 29 30 as follows: 31

- - 2. Three credits in mathematics at the Algebra I level or higher from the list of courses that qualify for state university admission;
  - 3. Three credits in natural science, two of which must have a laboratory component;
    - 4. Three credits in social sciences;
  - 5. Two credits in the same second language unless the student is a native speaker of or can otherwise demonstrate competency in a language other than English. If the student demonstrates competency in another language, the student may replace the language requirement with two credits in other academic courses; and
    - 6. Three credits in electives; or
  - (c) Completion of a 3-year career preparatory program requiring successful completion of a minimum of 18 academic credits in grades 9 through 12. The 18 credits shall be primary requirements and shall be distributed as follows:
  - 1. Four credits in English, with major concentration in composition and literature;
  - 2. Three credits in mathematics, one of which must be Algebra I;
  - 3. Three credits in natural science, two of which must have a laboratory component;
    - 4. Three credits in social sciences;
  - 5. Two credits in the same second language unless the student is a native speaker of or can otherwise demonstrate competency in a language other than English. If the student demonstrates competency in another language, the student may

replace the language requirement with two credits in other academic courses; and

- 6. Three credits in electives.
- (2) Beginning with the 2004-2005 <del>2003-2004</del> school year, each district school board shall provide each student in grades 6 through 9 12 and their parents with information concerning the 3-year and 4-year high school graduation options listed in subsection (1), including the respective curriculum requirements for those options, so that with curriculum for the students and their parents may to select the postsecondary education or career plan that best fits their needs. The information must options shall include a timeframe for achieving each graduation option. Before a student may select an option other than meeting the requirements set forth in s. 1003.43, the student and his or her parent must meet with a school counselor for an explanation of the requirements and the pros and cons of each option.

> A student who selected an accelerated graduation program under s. 1003.429, Florida Statutes 2003, may continue that program, even though he or she was beyond the 9th grade at the time of choosing that option. The required grade point average that was applicable when the student made that choice remains applicable to him or her.

(3) Selection of one of the graduation options listed in subsection (1) is exclusively up to the student and parent. If the student and parent fail to select a graduation option, the student shall be considered to have selected the general requirements for high school graduation pursuant to paragraph 31 (1)(a).

- (4) District school boards  $\underline{may}$  shall not establish requirements for accelerated 3-year high school graduation options in excess of the requirements in paragraphs (1)(b) and (c).
- (5) Students pursuing accelerated 3-year high school graduation options pursuant to paragraph (1)(b) or paragraph (1)(c) are required to:
- (a) Earn passing scores on the FCAT as defined in s. 1008.22(3)(c).
- (b)1. Achieve a cumulative grade point average of 3.0
  2.0 on a 4.0 scale, or its equivalent, in the courses required for the by the chosen accelerated 3-year standard college preparatory program under high school graduation option pursuant to paragraph (1)(b);or
- 2. Achieve a cumulative grade point average of 2.5 on a 4.0 scale, or its equivalent, in the courses required for the 3-year career preparatory program under paragraph (1)(c).
- (6) Each district school board shall adopt rules allowing 10th-grade students to switch from one accelerated program to the other accelerated program. A student who selects an accelerated graduation program may switch at any time to the 4-year program.
- (7) If, at the end of the 10th grade, a student is not on track to meet the course or grade-point-average requirements of an accelerated graduation option, the student shall default to the standard 4-year graduation option.
- (8) (6) A student who meets all requirements prescribed in subsections (1) and (5) shall be awarded a standard diploma in a form prescribed by the State Board of Education.
  - Section 2. This act shall take effect July 1, 2004.
