An act relating to Broward County; providing for extending the corporate limits of the Town of Davie; providing for annexation of the unincorporated area known as Pine Island Ridge; providing for an election; providing for an effective date of annexation; providing for an interlocal agreement; providing for a continuation of certain Broward County regulations; providing for the transfer of public roads and rights-of-way; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. The legal description of the Pine Island Ridge
Area is as follows:

That portion of Section 17, Township 50 South, Range 41 East, Broward County, Florida, described as follows:

Beginning at a point on the municipal boundary of the Town of Davie, as established by Chapter 84-420, Laws of Florida, being the point of intersection of the West right-of-way line of Pine Island Road (Southwest 88 Avenue) and the South line of said Section 17;

an election on March 14, 2006, in accordance with the provisions
of the law relating to elections currently in force in Broward
County. The subject of said election shall be the annexation of
the Pine Island Ridge Area. Only registered voters residing in
the Pine Island Ridge Area as described in this act may vote in
said election. The voters residing in the Pine Island Ridge Area
shall, by majority vote of the voters participating in the
election, choose to be annexed into the Town of Davie or remain
unincorporated. Mail ballots shall not be used in this election;
however, voters may vote by absentee ballot as provided by law.

Section 3. Upon a majority of the registered voters participating in the election as provided in section 2 voting for annexation, the Pine Island Ridge Area described in section 1 shall be deemed a part of the Town of Davie on September 15, 2006, pursuant to s. 171.062, Florida Statutes, except as provided for in this act.

Section 4. An interlocal agreement shall be developed between the governing bodies of Broward County and the Town of Davie and executed prior to the effective date of the annexation as provided for in section 3. The agreement shall address infrastructure improvement projects and include a financially feasible plan for transitioning county services, buildings, infrastructure, waterways, and employees.

Section 5. Subsequent to the effective date of the annexation, any resident in the area to be annexed by this act into the Town of Davie shall be deemed to have met any residency requirements for candidacy for any municipal office.

Section 6. Nothing in this act shall be construed to affect or abrogate the rights of parties to any contracts,

whether the same be between Broward County and a third party or
between nongovernmental entities, which contracts are in effect
prior to the effective date of the annexation.

Section 7. Subsequent to the effective date of this act, within the limits of the Pine Island Ridge Area, no change in land use designation or zoning shall be effective, and no annexation by any municipality shall occur during the time period between the effective date of this act and the effective date of the annexation.

Section 8. <u>Upon annexation into the Town of Davie, the</u> following shall govern the area described in section 1:

- (1) The present land use designations and zoning districts provided for under the Broward County Comprehensive Plan and Code of Ordinances of Broward County shall remain the law governing the Pine Island Ridge Area, notwithstanding the fact that the Pine Island Ridge Area is now a part of the Town of Davie.
- (2) Any change of zoning districts or land use designations may only be accomplished by enactment of the vote of the majority of the full governing body of the Town of Davie plus one.
- (3) Notwithstanding subsections (1) and (2), any use, building, or structure that is legally in existence at the time that the Pine Island Ridge Area becomes a part of the Town of Davie, said use shall not be made a prohibited use by the Town of Davie, on the property of said use, for as long as the use shall continue, and not be voluntarily abandoned.
- Section 9. All public roads and the public rights-of-way associated therewith, on the Broward County Road System, lying
