FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

This bill does not affect House Principles. The sections of law proposed for repeal are obsolete (for instance, the due date for a report has passed or the program is not operating) or outdated.

B. EFFECT OF PROPOSED CHANGES:

During the interim, staff of the Governor's Office of Policy and Budget (OPB) reviewed the Florida Statues for obsolete and outdated plans, reports, and programs. The OPB solicited recommendations from the executive agencies regarding possible repeal. Only those sections the agencies agreed were appropriate candidates for repeal are contained in this bill.
