I. Summary:

CS/SB 528 (CS) substantially revises the Trust Fund for University Major Gifts program by revising the state matching scale for eligible private donations received by the state universities and the Florida Board of Governors Foundation for gifts made on or after July 1, 2006, as follows:

| Private Donation | State Match |
|-------------------------|-------------|
| \$100,000-\$499,999 | 25 percent |
| \$500,000-\$999,999 | 50 percent |
| \$1,000,000-\$2,999,999 | 75 percent |
| \$3,000,000 and above | 100 percent |

Bundled gifts are capped at \$1 million with a maximum match of 50 percent, while a single gift is limited to \$3 million for any given year. The CS restricts the maximum total amount of matching funds for any single gift to \$15 million, payable in equal annual installments over a five-year period.

The CS raises the threshold donation for state matching grants for endowed chairs to \$700,000 from \$600,000 for any donation made on or after July 1, 2006.

The state's total obligation for matching grants is \$125 million for all gifts made before July 1, 2006. Gifts and pledges received by the universities or the Florida Board of Governors Foundation before July 1, 2006, which are in excess of \$125 million, are not eligible for state match until July 1, 2006 and must be matched under the revised match criteria.

In addition, the CS eliminates the authority of the State Board of Education to authorize any university to encumber the state match from unexpended funds in a university operating budget. It also eliminates pro rata distribution for state matching funds, effectively requiring complete gifts to be funded. The CS also transfers the administration of the program from the State Board of Education to the Florida Board of Governors.

The Committee Substitute for CS/SB 528 allows donations of real property having a value of up to \$5 million to qualify for state matching funds under the Community College Facility Enhancement Challenge Grant Program or the University Facility Enhancement Grant Program. The Committee Substitute also provides for the return or transfer of donations for Eminent Scholar Endowed Chairs under certain circumstances.

This Committee Substitute for CS/SB 528 amends section 1011.94, 1011.32, and 1013.79 of the Florida Statutes.

II. Present Situation:

The Trust Fund for University Major Gifts is designed to provide donors with an incentive in the form of matching grants for donations for the establishment of permanent endowments. The funds must be invested, with the proceeds of the investment used to support libraries and instruction and research programs as defined by the State Board of Education. The matches are subject to appropriation.

According to the Division of Colleges and Universities, the matching gift program has established more than 2,300 permanent endowments worth \$1.24 billion from 1979 through 2004 as follows:¹

Prior to 2004, a significant waiting list was established as eligible donations exceeded legislative appropriations. In 2004, the Legislature appropriated \$94.8 million to match all gifts through December 1, 2003. According to the Department of Education, there is more than \$43.6 million in new requests for state matching funds as of January 10, 2005.

At the present time, a donation of real property is not eligible for state match under Community College Facility Enhancement Challenge Grant Program or the University Facility Enhancement Grant Program.

Also, presently there are a number of vacancies in the Eminent Scholar's Endowed Chairs within the university system.

III. Effect of Proposed Changes:

New College

The CS amends s. 1011.94, F.S., to make changes to conform the Trust Fund for University Major Gifts provisions to s. 1000.21(6), F.S., which defines New College as a state university for purposes of the education code.

Florida Board of Governors

The CS also makes conforming changes to reflect the creation of the Board of Governors under the state constitution. In particular, the CS provides that the Board of Governors shall: (1) define instruction and research programs eligible for the matching funds, (2) allocate the funds to a constituent university or the Board of Governors Foundation, (3) designate the procedures for submission, documentation and approval of a matching gift request, (4) establish accountability measures and develop restrictions on the use of matching funds, and (5) receive an annual report from each foundation receiving matching funds.

Florida Board of Governors Foundation

The CS authorizes matching grants for donations made to the Florida Board of Governors Foundation. Previously, the Board of Regents Foundation had received an endowment that was matched under the program. Upon dissolution of the Board of Regents, the endowment, in the amount of approximately \$1 million, along with investment earnings, was disbursed to the state universities for use in funding scholarships. Donors have contacted the Board of Governors about the prospect of providing donations for the benefit of the state university system as a whole. Accordingly, the CS provides a mechanism for such donations by authorizing the Florida Board of Governors Foundation to receive state matching funds on the same basis as any university under the program.

Although the uses of the donations and their corresponding state match are limited to supporting libraries, instruction, and research programs as defined by the Board of Governors, gifts to the Board of Governors Foundation may not receive the same review that university gifts receive under the program. Officers of the foundation serve as members of the Board of Governors, including the chair, who serves as both the chair of the board and the foundation, which creates a possible conflict of interest.

The CS requires any private donation to the Board of Governors Foundation under the program must be expended for the direct benefit of a university or universities consistent with the donor's gift or pledge agreement.

Major Gifts

The CS maintains the current donation scale for donations which are approved by the Board of Governors and are on the pending list before July 1, 2006. For gifts made on or after July 1, 2006, the CS revises the state matching as follows:

| Private Donation | State Match |
|-------------------------|-------------|
| \$100,000-\$499,999 | 25 percent |
| \$500,000-\$999,999 | 50 percent |
| \$1,000,000-\$2,999,999 | 75 percent |
| \$3,000,000 and above | 100 percent |

The CS also provides a maximum amount of matching funds for any single gift in a given year at \$3 million and caps the overall matching funds for any single gift at \$15 million, payable over 5 years in equal amounts, subject to available funds.

The revision in the state matching schedule is designed to ensure that a greater number of institutions and donations receive a state match. Approximately 93 percent of the private donations under the program are for less than \$1 million. As gifts are matched on a first-come, first-served basis, large donations tend to reduce the amount of funds available for the remaining gifts.

In order to reduce the practice of bundling gifts to attain a higher state matching grant, the CS restricts bundled gifts to a maximum of \$1 million and a maximum match of fifty percent.

The CS revises the purposes for which a donation must be made to require that the donation must be used to support university priorities as established by the university boards of trustees.

The CS eliminates the authority of the State Board of Education to authorize any university to encumber the state match from unexpended funds in a university operating budget. It also eliminates pro rata distribution for state matching funds, effectively requiring complete gifts in order to be funded.

In order to reduce the state's exposure to excessive donations prior to the change in the matching criteria, the CS imposes a cap on the state's matching obligation under the program at \$125 million for all gifts made before July 1, 2006. Finally, each gift received before July 1, 2006 that is in excess of a \$125 million cap may only be matched under the new matching criteria and the match can only be made on or after July 1, 2006.

The Committee Substitute for CS/SB 528 allows donations of real property having a value of up to \$5 million to qualify for state matching funds under the Community College Facility Enhancement Challenge Grant Program or the University Facility Enhancement Grant Program.

Endowed Chairs

The CS raises the minimum threshold for receiving a matching gift for endowed chairs from

\$600,000 to \$700,000 for gifts and pledges made on or after July 1, 2006.

The Committee Substitute also provides that a donor may request the transfer of a donation to another university or the return of a donation for an Eminent Scholar Endowed Chair if the chair is vacant for more than 12 months.

Effective date

The CS has an effective date of July 1, 2005.

V. Economic Impact and Fiscal Note:

A. Tax/Fee Issues:

B. Private Sector Impact:

A reduction in the state matching scale could have an indeterminate impact on the amount of donations as certain donors may have insufficient funds, without the state match, to realize their donation goals.

C. Government Sector Impact:

The Department of Education has estimated that the revised matching scale would have saved the state approximately \$8.9 million (27%) in 2003.

The addition of real estate as a donation in the Community College Facility Enhancement Challenge Grant Program or the University Facility Enhancement Grant Program eligible for state match has the potential to increase donations in the programs and hence state matching funds in an indeterminate amount.

The return of an eminent scholars donation to a donor with its accompanying match returned to the state would increase General Revenue Fund receipts in an indeterminate amount.
