### **SUMMARY ANALYSIS**

House Bill 879 requires the Department of Education to evaluate the extent to which school districts are providing art instruction, and analyze student FCAT scores compared to art instruction. The evaluation and analysis shall be reported to the Governor and presiding officers by March 1, 2006.

The bill sets an effective date upon becoming law.

# **Substantive Impact**

House Bill 879 requires an evaluation and report on art instruction in kindergarten through grade 12, and the relationship of art instruction to student FCAT scores.

# **Fiscal Impact**

This bill does not appear to have a fiscal impact on state or local governments.

### **FULL ANALYSIS**

### I. SUBSTANTIVE ANALYSIS

#### A. HOUSE PRINCIPLES ANALYSIS:

The bill does not appear to implicate any of the House Principles.

### B. EFFECT OF PROPOSED CHANGES:

Current law (section 1003.43(1)(h)1, F. S.) requires one credit in practical arts or exploratory career education for high school graduation. The credit can be earned through a career education course; a course in performing fine arts to be selected from music, dance, painting or sculpture; or one-half credit each in practical arts career education or exploratory career education and performing arts.

In addition, the State Board of Education has approved Sunshine State Standards for prekindergarten through grade 12 in dance, music, theater and visual arts.

House Bill 879 requires the Department of Education to evaluate the extent to which the Sunshine State Standards in art are being taught in Florida's 67 school districts. The bill also requires the Department to analyze student FCAT scores as compared to art instruction and enrollment in art courses. The evaluation and analysis shall be reported to the Governor and presiding officers by March 1, 2006.

The bill takes effect upon becoming law.
