14	Section 1. Paragraph (a) of subsection (22) of section
15	121.021, Florida Statutes, is amended to read:
16	121.021 DefinitionsThe following words and phrases
17	as used in this chapter have the respective meanings set forth
18	unless a different meaning is plainly required by the context:
19	(22) "Compensation" means the monthly salary paid a
20	member by his or her employer for work performed arising from
21	that employment.
22	(a) Compensation shall include:
23	1. Overtime payments paid from a salary fund.
24	2. Accumulated annual leave payments.
25	3. Payments in addition to the employee's base rate of
26	pay if all the following apply:
27	a. The payments are paid according to a formal written
28	policy that applies to all eligible employees equally;
29	b. The policy provides that payments shall commence no
30	later than the 11th year of employment;

Amounts withheld for tax sheltered annuities or deferred compensation programs, or any other type of salary 5 б reduction plan authorized under the Internal Revenue Code. 7 5. Payments made in lieu of a permanent increase in 8 the base rate of pay, whether made annually or in 12 or 26 9 equal payments within a 12-month period, when the member's 10 base pay is at the maximum of his or her pay range. For all periods prior to July 1, 2006, employer-reported retirement contributions on these 2.4 25 supplemental payments shall be compensation. Section 2. It is declared by the Legislature that 26 firefighters, emergency medical technicians, and paramedics 27 2.8 perform state and municipal functions; that it is their duty to protect life and property at their own risk and peril; that 29 30 it is their duty to continuously instruct school personnel, public officials, and private citizens about safety; and that 31

1	their activities are vital to the public safety. Therefore,
2	the Legislature declares that it is a proper and legitimate
3	state purpose to provide a uniform retirement system for the
4	benefit of firefighters, emergency medical technicians, and
5	paramedics, and intends, in implementing the provisions of s.
б	14, Art. X of the State Constitution as they relate to
7	municipal and special district pension trust fund systems and
8	plans, that such retirement systems or plans be managed,
9	administered, operated, and funded in such manner as to
10	maximize the protection of pension trust funds. Pursuant to s.
11	18, Art. VII of the State Constitution, the Legislature
12	determines and declares that the provisions of this act
13	<u>fulfill an important state interest.</u>
14	Section 3. This act shall take effect July 1, 2006.
