The Legislature finds that victims of human trafficking 2.5 are subjected to force, fraud, or coercion for the purpose of 26 27 sexual exploitation or forced labor. 2.8 (b) The Legislature finds that while many victims of human trafficking are forced to work in prostitution or the 29 sexual entertainment industry, trafficking also occurs in 30 forms of labor exploitation, such as domestic servitude,

restaurant work, janitorial work, sweatshop factory work, and 2 migrant agricultural work. (c) The Legislature finds that traffickers use various 3 4 techniques to instill fear in victims and to keep them 5 enslaved. Some traffickers keep their victims under lock and 6 key.
