I. Summary:

The PCS makes changes necessary to implement the decisions included in the Health and Human Services budget. The bill makes permanent the policies included in the fiscal year 2005-2006 General Appropriations Act, Chapter 2005-70, Laws of Florida, and the appropriations implementing bill, Chapter 2005-71, Laws of Florida.

This bill amends s. 391.0661, F.S., deleting provisions requiring the Agency for Health Care Administration to make certain adjustments to the home and community-based services. The bill also requires the Agency for Persons with Disabilities (APD) to report to the Governor and Legislature the financial status of the home and community-based service waivers. APD is required to remain within appropriation based on the November 1, 2003 rates and is authorized to make any adjustment necessary to remain within the appropriation.

This bill amends s. 440.02, F.S., deleting provisions providing for the expiration of an exemption from workers' compensation law for certain clients enrolled in the Medicaid program who are served by adult day training services.

II. Present Situation:

In fiscal year 2005-2006, the Agency for Persons with Disabilities (APD) was required in SB 2600 and SB 2602 to provide quarterly reports to the Executive Office of the Governor, the chair of the Senate Ways and Means Committee, and the chair of the House Fiscal Council regarding the financial status of the Home and Community Based Services Waivers.

The agency was also required to remain within the appropriation based on the current provider rates implemented November 1, 2003. The agency was authorized to make any adjustment necessary to stay within the appropriation.

Clients receiving adult day training services under chapter 393 who are excluded from the definition of employment under s. 443.1216(4)(d), F.S., are exempt from workers' compensation laws under s. 440.02, F.S.

The provisions of Chapter 2005-70 and Chapter 2005-71, Laws of Florida, expire July 1, 2006.

The Agency for Health Care Administration in consultation with the Agency for Persons with Disabilities, may implement cost control measures including rate reductions in order to remain within the appropriation.

III. Effect of Proposed Changes:

Section 1. This bill amends s. 391.0661, F.S., deleting provisions requiring the Agency for Health Care Administration to make certain adjustments to the home and community-based services. The bill also requires the Agency for Persons with Disabilities (APD) to report to the Governor and Legislature the financial status of the home and community-based service waivers. APD is required to remain within appropriation based on the November 1, 2003 rates and is authorized to make any adjustment necessary to remain within the appropriation.

Section 2. This bill amends s. 440.02, F.S., deleting provisions providing for the expiration of an exemption from workers' compensation law for certain clients enrolled in the Medicaid program who are served by adult day training services.
