23	(b) <u>Effective July 1, 2006,</u> there is imposed upon each
24	hospital an assessment in an amount equal to 0.5 $\frac{1}{2}$ percent of
25	the annual net operating revenue for outpatient services for
26	each hospital, <u>the</u> such revenue to be determined by the
27	agency, based on the actual experience of the hospital as
28	reported to the agency. While prior year report worksheets may
29	be reconciled to the hospital's audited financial statements,
