**Senate Amendment**

On page 1, line 19, through page 2, line 19, delete  
those lines

and insert:

(d)1. Committees of continuous existence,  
electioneering communications organizations, organizations  
exempt from taxation under 26 U.S.C. s. 527 other than a  
political party, and organizations exempt from taxation under  
26 U.S.C. s. 501(c)(4) shall not, in any election, accept  
contributions in excess of \$500 from an individual or group  
if, during the current election period ending on the date of  
the next general election, the committee or organization  
directly or indirectly through one or more intermediaries:

a. Reimburses or pays for any expenses of the  
Governor, the Lieutenant Governor, a member of the Cabinet, a  
state legislator, a candidate for any of these offices, an  
employee or agent of the officer or candidate, or a member of

1 the officer's or candidate's immediate family.

2           b. Is, in whole or in part, established, organized,  
3 operated, or controlled by the Governor, the Lieutenant  
4 Governor, a member of the Cabinet, a state legislator, a  
5 candidate for any of these offices, an employee or agent of  
6 the officer or candidate, or a member of the officer's or  
7 candidate's immediate family, provided the committee or  
8 organization directly or indirectly makes or has made a  
9 contribution to, or an expenditure for the benefit of, the  
10 officer's or candidate's campaign for publicly-elected office.

11           c. Knowingly receives contributions solicited by,  
12 caused to be solicited by, or accepted on behalf of the  
13 committee or organization by the Governor, the Lieutenant  
14 Governor, a member of the Cabinet, a state legislator, a  
15 candidate for any of these offices, an employee or agent of  
16 the officer or candidate, or a member of the officer's or  
17 candidate's immediate family, provided the committee or  
18 organization directly or indirectly makes or has made a  
19 contribution to, or an expenditure for the benefit of, the  
20 officer's or candidate's campaign for publicly-elected office  
21 in an amount exceeding \$500 in the aggregate in any election.
