SUMMARY ANALYSIS

This bill increases the minimum amount at which certain contracts with the Hillsborough County Aviation Authority are subject to competitive bidding from \$15,000 to \$30,000. The bill also increases the contractual amount for when a surety is required from \$15,000 to \$50,000.

This bill is effective upon becoming law.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

Provide Limited Government – This bill may allow the Hillsborough County Aviation Authority to operate more efficiently by increasing the threshold amount for competitive bidding.

B. EFFECT OF PROPOSED CHANGES:

Present Situation

Hillsborough County Aviation Authority

The Authority was created in 1945 by ch. 23339, L.O.F., which has subsequently been amended by special acts, which were codified by ch. 2003-370. The Authority is an independent special district which has exclusive jurisdiction and management over all airports in the county except those owned by private persons.

Award of contracts

When the cost or value of a contract exceeds \$15,000, the Authority must solicit competitive bids and contract with the lowest responsive bid from a qualified responsible bidder. The Authority may reject any and all bids.

When the Authority enters into a contract subject to s. 255.05, F.S., that is in excess of \$15,000, for the construction, improvement or repair of Authority facilities, a surety is required which would guarantee the faithful performance of the contract.

Effect of Proposed Changes

This bill increases the amount for contracts subject to competitive bidding to \$30,000 for the construction, improvement, and repair of the Authority, as well as for supplies and materials. This bill also increases the amount for when a surety is required to contracts exceeding \$50,000.

C. SECTION DIRECTORY:

Section 1: Amends ch. 2003-370, L.O.F., by increasing the threshold amount for those contracts that would require competitive bidding and the amount for when a surety is required.

Section 2: Provides an effective date of upcoming becoming law.
