9	(4)(3) Any law enforcement officer who observes a
10	child left unattended or unsupervised in a motor vehicle in
11	violation of subsection (1) may use whatever means are
12	reasonably necessary to protect the minor child and to remove

14	(5)(4) If the child is removed from the immediate
15	area, notification should be placed on the vehicle.
16	(6)(5) The child shall be remanded to the custody of

24	SENATE SUMMARY
25	Provides that it is a misdemeanor of the second degree, rather than a noncriminal traffic violation, to leave a
26	child unattended in a motor vehicle longer than 15 minutes. Provides that a violation that leaves a child
27	seriously harmed is a felony of the third degree.
