16	Section 1. Subsection (4) of section 741.31, Florida
17	Statutes, is amended to read:

20	(4)(a) A person who willfully violates an injunction
21	for protection against domestic violence issued pursuant to s.
22	741.30, or a foreign protection order accorded full faith and
23	credit pursuant to s. 741.315, by:
24	1. Refusing to vacate the dwelling that the parties
25	share;
26	2. Going to, or being within 500 feet of, the
27	petitioner's residence, school, place of employment, or a
28	specified place frequented regularly by the petitioner and any
29	named family or household member;
30	3. Committing an act of domestic violence against the

1 3.4. Committing any other violation of the injunction 2 through an intentional unlawful threat, word, or act to do violence to the petitioner; 3 4.5. Telephoning, contacting, or otherwise 4 communicating with the petitioner directly or indirectly, 5 6 unless the injunction specifically allows indirect contact 7 through a third party; 5.6. Knowingly and intentionally coming within 100 8 feet of the petitioner's motor vehicle, whether or not that 9 vehicle is occupied; 10 6.7. Defacing or destroying the petitioner's personal 11 12 property, including the petitioner's motor vehicle; or 13 7.8. Refusing to surrender firearms or ammunition if ordered to do so by the court 14 15 commits a misdemeanor of the first degree, punishable as 16 17 provided in s. 775.082 or s. 775.083. (b)1. It is a violation of s. 790.233, and a 18 misdemeanor of the first degree, punishable as provided in s. 19 775.082 or s. 775.083, for a person to violate a final 2.0 21 injunction for protection against domestic violence by having 22 in his or her care, custody, possession, or control any 23 firearm or ammunition. 2. It is the intent of the Legislature that the 2.4 disabilities regarding possession of firearms and ammunition 25 26 are consistent with federal law. Accordingly, this paragraph 27 does shall not apply to a state or local officer as defined in 2.8 s. 943.10(14), holding an active certification, who receives 29 or possesses a firearm or ammunition for use in performing official duties on behalf of the officer's employing agency, 30 unless otherwise prohibited by the employing agency. 31
