Weaver's medical expenses to date total more than \$400,000, and 25 WHEREAS, Verlin C. Weaver filed suit against the City 26 of Fernandina Beach (Case No. 03-251-CA-A) in the Circuit 27

WHEREAS, subsequently, the parties agreed to settle the 31 case, and, on June 1, 2004, they entered into a consent final
