#### SUMMARY ANALYSIS

The Open Government Sunset Review Act requires the Legislature to review each public records and each public meetings exemption five years after enactment. If the Legislature does not reenact the exemption, it is automatically repealed on October 2<sup>nd</sup> of the fifth year after enactment.

Current law provides a public records exemption for building plans, blueprints, schematic drawings, and diagrams depicting the internal layout and structural elements of a building, arena, stadium, water treatment facility, or other structure owned or operated by an agency. The exempt information may be released: to another governmental entity; to a licensed architect, engineer, or contractor who is performing work on or related to the building, arena, stadium, water treatment facility, or other structure owned or operated by an agency; or upon a showing of good cause before a court of competent jurisdiction. In creating the exemption for building plans and blueprints, the Legislature found that it was a public necessity in order to ensure the safety of government infrastructures and to ensure public safety.

The bill reenacts the public records exemption and reorganizes the exemption. The exemption will repeal on October 2, 2007, if this bill does not become law.

The bill does not appear to have a fiscal impact on state or local governments.

# I. SUBSTANTIVE ANALYSIS

## A. HOUSE PRINCIPLES ANALYSIS:

This bill does not appear to implicate any of the House Principles.

### B. EFFECT OF PROPOSED CHANGES:

## BACKGROUND

#### Open Government Sunset Review Act

The Open Government Sunset Review Act<sup>1</sup> sets forth a legislative review process for newly created or substantially amended public records or public meetings exemptions. It requires an automatic repeal of the exemption on October 2<sup>nd</sup> of the fifth year after creation or substantial amendment, unless the Legislature reenacts the exemption.

The Act provides that a public records or public meetings exemption may be created or maintained only if it serves an identifiable public purpose, and may be no broader than is necessary to meet one of the following purposes:

- Allowing the state or its political subdivisions to effectively and efficiently administer a
  governmental program, which administration would be significantly impaired without the
  exemption;
- Protecting sensitive personal information that, if released, would be defamatory or would jeopardize an individual's safety. However, only the identity of an individual may be exempted under this provision; or,
- Protecting trade or business secrets.

If, and only if, in reenacting an exemption that will repeal, the exemption is expanded (essentially creating a new exemption), then a public necessity statement and a two-thirds vote for passage are required because of the requirements of Art. 1, s. 24(c), Florida Constitution. If the exemption is reenacted with grammatical or stylistic changes that do not expand the exemption, if the exemption is narrowed, or if an exception to the exemption is created (e.g., allowing another agency access to the confidential or exempt records), then a public necessity statement and a two-thirds vote for passage are not required.

#### **Building Plans and Blueprints**

Current law provides a public records exemption for building plans, blueprints, schematic drawings, and diagrams<sup>2</sup> depicting the internal layout and structural elements of a building, arena, stadium, water treatment facility, or other structure owned or operated by an agency.<sup>3</sup> The exempt information may be released:

- To another governmental entity if disclosure is necessary for the receiving entity to perform its duties and responsibilities.
- To a licensed architect, engineer, or contractor who is performing work on or related to the building, arena, stadium, water treatment facility, or other structure owned or operated by an agency.

• Upon a showing of good cause before a court of competent jurisdiction.

In creating the exemption for building plans and blueprints, the Legislature found that it was a public necessity in order to ensure the safety of government infrastructures and to ensure public safety. The finding further stated that such building plans, blueprints, schematic drawings, and diagrams are a vital component of public safety and if made publicly available, the ability of persons who desire to harm individuals located in or using those structures would be increased.<sup>4</sup>

Pursuant to the Open Government Sunset Review Act, the exemption will repeal on October 2, 2007, unless reenacted by the Legislature.

### EFFECT OF BILL

International terrorists continue to demonstrate the ability to plan and carry out sophisticated acts of terrorism. Their capability appears to be no less today than at the time of the Legislature's original findings in 2002. As such, the bill removes the repeal date, thereby reenacting the public records exemption. It also reorganizes the exemption.

C. SECTION DIRECTORY:

Section 1 amends s. 119.071, F.S., to remove the repeal date.

Section 2 provides an effective date of October 1, 2007.
