The law enforcement agency that made the request to 8 inspect or copy a public record shall give notice to the custodial agency when the criminal intelligence information or 9 10 criminal investigative information is no longer active, so that the request made by the law enforcement agency, the 11 12 custodian's response to the request, and information that 13 would identify the public record requested are available to 14 the public. c. This exemption is remedial in nature, and it is the 15 intent of the Legislature that the exemption be applied to 16 17 requests for information received before, on, or after the 18 effective date of this paragraph.
