An act relating to the Primary Care Access Network; creating a pilot program to provide extended operating hours for the purpose of offering health care services at overcrowded clinics in the Primary Care Access Network in specified counties; directing the Agency for Health Care Administration to establish the pilot program in Orange, Pasco, Manatee, Sarasota, and DeSoto Counties; requiring the agency to develop procedures for operating the pilot program; requiring the agency to submit a report with recommendations to the Governor and the Legislature by a specified date; providing an appropriation; providing a contingent effective date. Be It Enacted by the Legislature of the State of Florida:

17 Section 1. (1) The Legislature finds that the Primary Care Access Network (PCAN) was founded to address the needs of 18 19 the uninsured and those who are medically needy by providing a 20 system of service delivery that builds upon the strengths of its current health provider partners. There has been an average 32-21 22 percent decrease in nonurgent emergency room services used by the uninsured in areas where one of the clinics is in operation. 23 In accordance with these findings, the Agency for Health Care 24 25 Administration shall establish a 2-year pilot program in Orange 26 and Pasco Counties and a 1-year pilot program in Manatee, Sarasota, and DeSoto Counties to offer health care services 27 during the weekend and after regular business hours during the 28
