22	(a) The department shall develop a Horse Country license
23	plate as provided in this section. Horse Country license plates
24	must bear the colors and design approved by the department. The
25	word "Florida" must appear at the top of the plate, and the words
26	"Horse Country" must appear at the bottom of the plate.
27	(b) The license plate annual use fees shall be distributed
28	to PCMI Properties, Inc., to fund its activities, programs, and

30	Properties, Inc., may retain all revenue from the annual use fees
31	until up to \$60,000 of its documented startup costs for
32	developing and establishing the plate have been recovered.
33	Thereafter, revenue from the annual use fees shall be used as
34	<u>follows:</u>
35	1. Up to 25 percent of the annual use fee revenue may be
36	used for promotion and marketing of the plate.
37	2. Funds may be used as necessary for annual audit or
38	compliance affidavit costs.
39	3. The remaining revenue shall be used for programs
40	involved in the rehabilitation of at-risk youth as directed by
41	the Board of Trustees of PCMI Properties, Inc. Such funds may be
42	used to provide educational materials, athletic equipment,
43	transportation, food, medical services, counseling, scholarships,
44	and other direct administrative and program expenses. The funds
45	may also be used as grants for expansion of youth rehabilitation
46	programs in the state. Special consideration shall be given to
47	programs using horses and other livestock in the efforts to
48	redirect at-risk youth.
