26	(a) The Florida Veterinary Medical Association;
27	(b) The Cat Fancier Association;
28	(c) The Florida Association of Kennel Clubs;
29	(d) A humane society organization;
30	(e) The Florida Animal Control Association;
31	(f) The National Rifle Association; and
32	(g) One citizen member not otherwise associated with any of

34	(4) The Commissioner of Agriculture may appoint up to three
35	nonvoting honorary members. Nominees must be individuals,
