I. Summary:

This bill creates the Reduced Cigarette Ignition Propensity and Firefighter Protection Enforcement Trust Fund within the Division of Alcoholic Beverages and Tobacco (division) of the Department of Business and Professional Regulation. Moneys credited to the trust fund shall consist of certification fees submitted by cigarette manufacturers pursuant to s. 633.042, F.S., which is created by Senate Bill (SB) 2640.

The trust fund must be terminated by July 1, 2012, in accordance with art. III, s. 19(f), Florida Constitution. Before scheduled termination, it must be reviewed as provided in s. 215.3206, F.S.

The bill provides an effective date of July 1, 2008, if SB 2640 or similar legislation is adopted in the same legislative session or extension thereof and becomes law.

This bill creates an unnumbered section of the Florida Statutes.

II. Present Situation:

Creation and Operation of Trust Funds

A trust fund consists of moneys received by the state which under law or under trust agreement are segregated for a purpose authorized by law. Article III, s. 19(f), of the State Constitution, governs the creation of trust funds. This constitutional provision prohibits the creation by law of a trust fund of the state or other public body without a three-fifths vote of the membership of each house of the Legislature. This provision further specifies that a trust fund must be created in a separate bill for that purpose only.

In addition, the Legislature has established criteria governing the establishment of trust funds. Under these criteria, a law creating a trust fund must, at a minimum, specify:

- The name of the trust fund;
- The agency or branch of state government responsible for administering the trust fund; and
- The sources of moneys to be credited to the trust fund or specific sources of receipts to be deposited in the trust fund.²

The Chief Financial Officer is directed to invest all the trust funds and all agency funds of each state agency.³ Under current law, any balance of an appropriation for any given fiscal year that is remaining after lawful expenditures have been charged against it reverts to the fund from which the Legislature appropriated it and shall be available for re-appropriation.⁴ Any reversion of appropriations provided from the General Revenue Fund must be transferred to the General Revenue Fund within 15 days after the reversion, unless otherwise provided by federal or state law, including the General Appropriations Act.⁵

State trust funds terminate no more than four years after the effective date of the act that created them, unless they are re-created by the Legislature with a three-fifths vote of the House and the Senate.

III. Effect of Proposed Changes:

This bill creates the Reduced Cigarette Ignition Propensity and Firefighter Protection Enforcement Trust Fund within the Division of Alcoholic Beverages and Tobacco (division). The balance of the trust fund at the end of any fiscal year is to remain in the trust fund for use in subsequent years.

This bill is tied to Senate Bill (SB) 2640, which requires cigarettes to meet certain cigarette ignition propensity standards. Funds credited to the trust fund consist of certification fees paid by cigarette manufacturers. This bill does not specify the requirements or purposes that the trust

fund is established to meet. It appears that the trust fund may be designed to help defray processing, enforcement, oversight, and similar activities of the division under s. 633.042, F.S., which is the cigarette regulatory program SB 2640 creates.

The trust fund must be terminated on July 1, 2012, unless terminated sooner, in accordance with the Florida Constitution.⁶ State trust funds shall terminate within four years after the effective date of the act authorizing the trust fund unless a shorter time period is set by the Legislature.

The bill provides for an effective date of July 1, 2008, provided that SB 2640 or similar legislation is adopted in the same legislative session or an extension thereof and becomes law.

C. Trust Funds Restrictions:

The bill creates the Reduced Cigarette Ignition Propensity and Firefighter Protection Enforcement Trust Fund and seems to comply with s. 19(f), Art. III, Florida Constitution, relating to the creation and termination of trust funds. The bill must have a three-fifths vote of the membership of each house of the Legislature to become law.

V. Fiscal Impact Statement:

A. Tax/Fee Issues:

B. Private Sector Impact:

The certification fees submitted by cigarette manufacturers, under s. 633.042, F.S. (proposed for creation by Senate Bill 2640), will provide funds to the Reduced Cigarette Ignition Propensity and Firefighter Protection Enforcement Trust Fund.

C. Government Sector Impact:

The bill does not specify the purpose of the trust fund. It is presumed that the trust fund will provide a source of funds that the Legislature can appropriate to support activities of the Department of Business and Professional Regulation related to the new cigarette regulatory program.
