29	social work without obtaining and possessing a license or

31	(2) It shall be a misdemeanor of the first degree,
32	punishable as provided in s. 775.082 or s. 775.083, for a
33	person, for or without compensation, to hold himself or herself
34	out to the public as a social worker either directly or through
35	a governmental or private organization, entity, or agency unless
36	that person:
37	(a) Possesses at least a bachelor's or master's degree in
38	social work from a social work program accredited by or from an
39	institution that is an active candidate for accreditation as a
40	social work program by the Council on Social Work Education; or
41	(b) Completes, at a university or college outside the

43	Foreign Equivalency Determination Service of the Council on
